Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

<u>CITATION</u>

A Citation is hereby issued to Alexander Training Institute of Los Angeles, Inc., Owner of Alexander Training Institute of Los Angeles (Institution) located at 1526 14th Street, #110, Santa Monica, CA 90404, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) sections 94936 and 94932; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

BACKGROUND

On May 24, 2019, Bureau staff attempted to conduct an unannounced Compliance inspection at the Institution. Upon arrival, no one was at the Institution and the front door was locked. Bureau staff confirmed that the Institution's website and catalog state that office hours are Monday through Friday, 9:00 am to 1:00 pm.

At approximately 10:00 am, an instructor and students arrived. The Director of the Institution was unable to be present during the inspection and the instructor on site could not assist Bureau staff with obtaining items that were needed for the inspection, therefore the inspection was not completed.

VIOLATION

#	Below you will find the California Education Code (CEC) and/or Title 5 of the California Code of Regulations (5, CCR code) section(s) of law you are charged with violating.
1.	Violation: CEC Section 94932.5 (a) – Announced and Unannounced Compliance Inspections (a) As part of its compliance program, the bureau shall perform announced and unannounced inspections of institutions at least every five years.

5, CCR Section 71930 (e) - Maintenance of Records

(e) All records that the institution is required to maintain by the Act or this chapter shall be made immediately available by the institution for inspection and copying during normal business hours by the Bureau and any entity authorized to conduct investigations.

On May 24, 2019, Bureau staff attempted to conduct an unannounced Compliance inspection at the Institution. There was no one at the Institution and the front door was locked. At approximately 10am, an instructor and students arrived at the Institution, however there were no personnel available to assist Bureau staff with obtaining the items needed for the inspection.

Order of Abatement:

The Bureau orders the Institution to submit a written policy of how with 5, CCR section 71930 (e) will be maintained.

Assessment of Fine

The fine for this violation is <u>\$5,000.00</u>

ASSESSMENT OF A FINE

In accordance with CEC section 94936; and 5, CCR sections 75020 and 75030, the Bureau hereby orders this assessment of fine in the amount of **\$5,000.00** for the violations described above. **Payment must be made, to the Bureau, within** <u>**30 days**</u> from the date of service of the Citation.

COMPLIANCE WITH ORDER OF ABATEMENT

In accordance with the provisions of CEC section 94936 and 5, CCR section 75020 the Bureau hereby issues the order(s) of abatement described above. **Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within <u>30 days</u> from the date of service of the Citation.**

APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing' form (enclosed) within <u>30 days</u> from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.* Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **March 8, 2020**, you will be deemed to have waived or forfeited your right to appeal this matter.

EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **February 7, 2020**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **March 8, 2020**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
