Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

CITATION

A Citation is hereby issued to Ann Balasuriya, Owner of Montessori Teacher Training Institute (Institution) located at 19900 El Toro Road, Silverado Canyon, CA 92679, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) sections 94936 and 94932; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

BACKGROUND

On May 27, 2020, the Bureau issued Citation Number 1920313 for failing to submit STRF Assessment Reporting Forms and failing to pay the annual fees. As of September 3, 2020, the citation is currently outstanding.

Additionally, on February 26, 2020, an unannounced Compliance inspection was conducted at the Institution. The Institution representative was unable to provide access to requested documentation as the documents were at an administrative location six hours away.

VIOLATION

- # Below you will find the California Education Code (CEC) and/or Title 5 of the California Code of Regulations (5, CCR code) section(s) of law you are charged with violating.
- 1. **5, CCR Section 71930 (e)- Maintenance of Records**"(e) All records that the Institution is required to maintain by the Act or this chapter shall be made immediately available by the institution for inspection and copying during normal business hours by the Bureau and any entity authorized to conduct investigations."

5, CCR Section 76140 (b) - Record Keeping Requirements

(b) The qualifying institution shall maintain the data required under this section in an electronic format that is readily available and open to inspection by the Bureau upon request. The institution shall make the records immediately available to a Bureau representative conducting a site inspection or, upon written request, shall provide a copy within 14 calendar days of the request. All records shall be provided to the Bureau in an intelligible and orderly manner and in an electronic format."

The institution failed to provide access to requested documentation, specifically Student Files, Faculty Files CAO File, STRF supporting documentation, and SPFS supporting documentation as the documentation was at an administrative location six hours away. The data was not stored in an electronic format that was readily available and open to inspection by the Bureau upon request.

Order of Abatement:

The Bureau orders the Institution to submit a written policy or procedure of how future compliance with 5, CCR Sections 71930(e) and 76140(b) will be maintained.

Assessment of Fine

The fine for this violation is \$500.00

ASSESSMENT OF A FINE

In accordance with CEC section 94936; and 5, CCR sections 75020 and 75030, the Bureau hereby orders this assessment of fine in the amount of \$500.00 for the violations described above. Payment must be made, to the Bureau, within 30 days from the date of service of the Citation.

COMPLIANCE WITH ORDER OF ABATEMENT

In accordance with the provisions of CEC section 94936 and 5, CCR section 75020 the Bureau hereby issues the order(s) of abatement described above. **Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within 30 days** from the date of service of the Citation.

APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing' form (enclosed) within 30 days from the date of service of the Citation. If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **October 3, 2020**, you will be deemed to have waived or forfeited your right to appeal this matter.

EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **September 3**, **2020**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **October 3**, **2020**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
