Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

### **CITATION**

A Citation is hereby issued to Aberdeen College, Owner of Aberdeen College (Institution) located at 251 W 6th Street, #30, Los Angeles, CA 90020, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) sections 94936 and 94932; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

### BACKGROUND

On March 5, 2021, the Bureau received information alleging that the Institution was offering unapproved programs. On March 16, 2021, Bureau staff reviewed the Institution's school catalog for calendar years 2020-2021. Through the course of the investigation and evidence obtained, Bureau staff found material violations related to changes in educational objectives, programs leading to licensed professions, and changes in method of instructional delivery.

## VIOLATION(S)

- 1. **Violation**:
  - 5, CCR Section 71650(a) Application for a Change in Educational Objectives
  - "(a) An institution seeking to change its educational objectives shall complete the "Change in Educational Objectives" form (OBJ rev. 2/10) to obtain prior authorization. The form shall be submitted to the Bureau along with the appropriate fee as provided in Section 94930.5(c) of the Code. For an institution approved under section 94885 of the Code it shall be signed and dated by the signatory(ies) required by section 71380, and for an institution approved under section 94890 of the Code it shall be signed and dated by the signatory(ies) required by section 71390, and each fact stated

|    | <b>CEC Section 94899 - Approval Required for Programs Leading to Licensed Professions</b> "If an institution offers an educational program in a profession, occupation, trade, or career field that requires licensure in this state, the institution shall have an educational program approval from the appropriate state licensing agency to conduct that educational program in order that a student who completes the educational program, except as provided in Section 94905, is eligible to sit for any required licensure examination."   |  |  |
|    | On March 16, 2021, Bureau staff reviewed the Institution's 2020-2021 school catalog posted on their website and found that the Institution was offering the Certified Nurse Assistant and Home Health Aide programs to the public, however, the Institution did not obtain Bureau approval prior to offering the programs. In addition, Bureau staff found that the Institution has not obtained approval from the California Department of Public Health (CDPH) to offer the programs mentioned above. Therefore, the Institution is also in violation of CEC Section 94899 as the programs mentioned above also require approval by the CDPH.  |  |  |
|    | Order of Abatement:  The Bureau orders the Institution to submit an Application for a Change in Educational Objectives if they wish to offer the programs referenced above. Furthermore, the Institution shall not offer the programs referenced above until approval from the Bureau is obtained. In addition, the Bureau orders the Institution to apply for the appropriate program approval from the appropriate state licensing agency. The Institution shall provide evidence of compliance to the Bureau.   |  |  |

## **CEC Section 94893 - Authorization Required for Substantive Change**

"If an institution intends to make a substantive change to its approval to operate, the institution shall receive prior authorization from the bureau. Except as provided in subdivision (a) of Section 94896, if the institution makes the substantive change without prior bureau authorization, the institution's approval to operate may be suspended or revoked."

On March 16, 2021, Bureau staff reviewed the Institution's 2020-2021 school catalog posted on their website and found that the Institution was offering courses in the Massage Therapy Program in Chinese (Mandarin) and Korean. The Institution has not obtained Bureau approval in order to offer the programs to be taught in any language other than English.

## **Order of Abatement:**

The Bureau orders the Institution to submit an Application for a Change in Method of Instructional Delivery if they wish to teach in a language other than English. The Institution shall not offer instruction in a language other than English until approval from the Bureau is obtained. The Institution shall submit evidence of compliance to the Bureau.

### **Assessment of Fine**

The fine for this violation is \$500.00

# **TOTAL ADMINISTRATIVE FINE DUE: \$2,000.00**

### ASSESSMENT OF A FINE

In accordance with CEC section 94936; and 5, CCR sections 75020 and 75030, the Bureau hereby orders this assessment of fine in the amount of \$2,000.00 for the violations described above. Payment must be made, to the Bureau, within 30 days from the date of service of the Citation.

## **COMPLIANCE WITH ORDER OF ABATEMENT**

In accordance with the provisions of CEC section 94936 and 5, CCR section 75020 the Bureau hereby issues the order(s) of abatement described above. **Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within 30 days** from the date of service of the Citation.

### **APPEAL OF CITATION**

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing' form (enclosed) within <u>30 days</u> from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.* 

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **May 1, 2021**, you will be deemed to have waived or forfeited your right to appeal this matter.

## **EFFECTIVE DATE OF CITATION**

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **April 1, 2021**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **May 1, 2021**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
