Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager for the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

### CITATION

A Citation is hereby issued to Lindsay Ta, Owner of Microblading L.A. (Institution) located at 20969 Ventura Blvd #, Woodland Hills, CA 9136 pursuant to Business and Professions Code section 125.9 and 149; California Education Code (CEC) section 94944; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violation(s) described below.

### BACKGROUND

On March 22, 2017, the Bureau received information alleging that the Institution was offering a 5-day course in microblading for \$6,000.00.

Through the course of the investigation, Bureau staff found that the allegation was substantiated as the Institution was offering courses for more than \$2,500.00 without Bureau approval.

Between January 4, 2018 and January 25, 2019, the Owner of the Institution worked with the Bureau, attended Compliance workshops, and ultimately came into compliance by lowering their cost of tuition, including all training materials, to \$2,499.

On February 20, 2020, the Bureau received a new complaint alleging that the Institution was operating as a private postsecondary institution without Bureau approval.

On October 13, 2020, Bureau staff reviewed the Institution's website which listed courses offered with tuition amounts of \$2,500.00, \$3,500.00, and \$7,000.00.

Through the course of the investigation and evidence obtained, the Bureau determined that the Institution was operating without Bureau approval and is not exempt under any provision of the Private Postsecondary Act of 2009.

VIOLATION(S)

1.	<p><b><u>Violation:</u></b></p> <p><b>CEC Section 94886 – Approval to Operate Required</b> <i>“Except as exempted in Article 4 (commencing with Section 94874) or in compliance with the transition provisions in Article 2 (commencing with Section 94802), a person shall not open, conduct, or do business as a private postsecondary educational institution in this state without obtaining an approval to operate under this chapter.”</i></p> <p><b>CEC Section 94817.5 – Approved to Operate or Approved</b> <i>“Approved to operate” or “approved” means that an institution has received authorization pursuant to this chapter to offer to the public and to provide postsecondary educational programs.”</i></p> <p><b>CEC Section 94868 – To Offer to the Public</b> <i>“To offer to the public” means to advertise, publicize, solicit, or recruit.”</i></p> <p><b>CEC Section 94869 – To Operate</b> <i>“To operate” means to establish, keep, or maintain any facility or location in this state where, or from which, or through which, postsecondary educational programs are provided.”</i></p> <p>On January 15, 2021, Bureau staff sent email correspondence to the Institution requesting a list of courses and tuition prices.</p> <p>On January 20, 2021, Bureau staff received a response from the Institution stating that all classes scheduled for February 2021 were on schedule and would be held in person. The response included a list the following courses and tuition prices:</p> <ul style="list-style-type: none"><li>• Brow Master Course (8 days) - \$5,000.00</li><li>• Brow Pro Course (6 days) - \$3,500.00</li><li>• Brow Basics Course (5 days) - \$2,500.00</li></ul> <p>To date, the Institution does not have a current Approval to Operate a private postsecondary institution nor are they operating under the specification of the exemption under CEC section 94874.</p> <p><b><u>Order of Abatement:</u></b> The Bureau orders that the Institution cease to operate as a private postsecondary educational institution, unless the Institution qualifies for an exemption under CEC section 94874. The Institution must discontinue recruiting or enrolling students and cease all instructional services and advertising in any form or type of media, including <a href="http://www.microbladingla.com">http://www.microbladingla.com</a>, and any other websites not identified here that are associated with the Institution, until such time as an approval to operate is obtained from the Bureau. The Institution must disconnect all telephone service numbers including, but not limited to, (855) 652-2769, that are associated with the Institution until such time as an approval to operate is obtained from the Bureau. To comply with the Order of Abatement the Institution must submit a school closure plan to the Bureau pursuant to California Education Code section 94926. The Institution must provide a roster of each student currently enrolled at the Institution. The roster must include the names of the students, their contact information (including</p>

phone number, email address, and physical address), the programs in which they are enrolled, the amount paid for the programs.

**Assessment of Fine**

The fine for this violation is \$100,000.00

**TOTAL ADMINISTRATIVE FINE DUE: \$100,000.00**

ASSESSMENT OF A FINE

In accordance with CEC section 94944; and 5, CCR section 75020(b), the Bureau hereby orders this assessment of a fine in the amount of **\$100,000.00** for the violations described above. **Payment must be made, to the Bureau, within 30 days from the date of service of the Citation.**

COMPLIANCE WITH ORDER OF ABATEMENT

In accordance with the provisions of 5, CCR section 75020 (b) the Bureau hereby issues the order(s) of abatement described above. In accordance with Business and Professions Code Section 149, the Bureau may disconnect any telephone service numbers used by an unapproved Institution. **Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within 30 days from the date of service of the Citation.**

APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing' form (enclosed) within 30 days from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.*

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **May 1, 2021**, you will be deemed to have waived or forfeited your right to appeal this matter.

EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **April 1, 2021**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **May 1, 2021**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
