Elizabeth Elias issues this citation in her official capacity as Deputy Bureau Chief of Enforcement of the Bureau for Private Postsecondary Education, California Department of Consumer Affairs (hereinafter referred to as the "Bureau").

LICENSING HISTORY

1. On or about January 23, 2015, the Bureau renewed an Approval to Operate a Private Postsecondary Institution to Institution Code 75356466, Professional Medical Careers Institute, hereinafter referred to as the "Institution". This Approval to Operate expired on or about January 23, 2020, and has not been renewed. An application for renewal of the Institution's Approval to Operate a Private Postsecondary Institution was received on January 24, 2020, and was subsequently denied on or about April 16, 2024. The Institution appealed the denial and may continue to operate pending the adjudication of the denied renewal application.

DISCIPLINE HISTORY

CITATION JURISDICTION

3. This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

CAUSE FOR CITATION & ASSESMENT OF FINE AND/OR ORDER OF ABATEMENT

4. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

CEC section 94897 (s)(u) – Prohibited Business Practices

Cause for Citation: On or about November 7, 2023, the Bureau received a complaint which alleged the Institution refused to provide transcripts to a former student due to an outstanding debt owed to the Institution. Evidence collected during an investigation showed that the Institution's enrollment agreement contains a policy noting students will not receive their transcript if an outstanding debt is owed. During an interview with the Institution, the Institution admitted it refused to provide the former student with transcripts, due to the outstanding debt owed.

Through the course of the investigation, the Bureau found the institutions policy to refuse to provide a transcript for a current or former student on the grounds that the student owes a debt, to be a direct violation of the Educational Debt Collection Practices Act, section 1788.93 of the Civil Code. Therefore, the institution is found to be in violation of CEC 94897 (s) and (u).

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class C" violation. The Institution is issued a fine of \$1,000.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to update the enrollment agreement and school policies to be in compliance with Civil Code section 1788.93 and to submit a statement of attestation they have updated the enrollment agreement and school policies. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Further, the Bureau orders the Institution to not refuse to provide transcripts to current and/or former students on the grounds that a student owes a debt.
