Violation	Code Section Violated	Description of the violation and required correction.
1	CEC § 94909 (a)(14) in conjunction with 5 CCR § 76215 (b)	Violation Description: Although the institution's 2024-2025 online catalog section " Expenses and Financial Aid " and under the header "California Student Tuition Recovery Fund", contains the required STRF statement, the statements reference the Bureau's old address (2535 Capitol Oaks Drive, Suite 400, Sacramento, CA 95833) and old telephone number (916-431-6959). Correction: The institution shall update the STRF disclosure in the institution's online catalog with the Bureau's current address (1747 North Market Blvd., Suite 225, Sacramento, California, 95834) and current telephone number (916-574-8900), pursuant to CEC § 94909 (a)(14) and 5 CCR § 76215 (b).
2	CEC § 94911 (b)	Violation Description: The institution's "V. Fall 2024" enrollment agreement failed to clearly identify Student Tuition Recovery Fund as nonrefundable charge.

		Correction: The institution shall update the enrollment agreement to identify Student Tuition Recovery Fund as nonrefundable charge, pursuant to CEC § 94911 (b).
3	CEC § 94911 (c)	<p>Violation Description: Although page 11 of the institution's "V. Fall 2024" enrollment agreement contain the required charges in underlined and capital letters, the charges are not on the same page in which the student's signature is required.</p> <p>Correction: The institution shall update the enrollment agreement to include the required charges in underlined and capital letters, on the same page in which the student's signature is required, pursuant to CEC § 94911 (c).</p>
4	CEC § 94911 (e)(2)	<p>Violation Description: The institution's "V. Fall 2024" enrollment agreement failed to include a statement that, if the student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds.</p> <p>Correction: The institution shall update the enrollment agreement, to include the above-mentioned statement, pursuant to CEC § 94911 (e)(2).</p>
5	5 CCR §76140 (a)(4)(5)(9)(10)(12)(13)	<p>Violation Description: The institution's 2024 3rd Quarter STRF supporting documentation failed to contain record of the student's:</p> <ul style="list-style-type: none"> (4) Local or mailing address, (5) Address at the time of enrollment, (9) Amount of STRF assessment collected, (10) Quarter in which the STRF assessment was remitted to the Bureau, <p>The institution's 2024 4th Quarter STRF supporting documentation failed to contain record of the student's:</p> <ul style="list-style-type: none"> (4) Local or mailing address, (5) Address at the time of enrollment, (10) Quarter in which the STRF assessment was remitted to the Bureau, (12) Total institutional charges charged, and (13) Total institutional charges paid.

		Correction: The institution shall update the 2024 3 rd & 4 th STRF supporting documentation, pursuant to 5 CCR § 76140 (a)(4)(5)(9)(10)(12)(13).

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
