1	5 CCR § 71810 (b)(5)	Violation Description: Although page 5 of the institution's 2025 catalog states instruction is offered in both Spanish and English, the catalog failed to establish the level of Spanish language proficiency required and the kind of documentation to determine Spanish language proficiency.
		Correction: The institution shall update its catalog to identify the level of Spanish language proficiency required and the kind of documentation to determine Spanish language proficiency, pursuant to 5 CCR § 71810 (b)(5).
2	CEC § 94909 (a)(5)	Violation Description: The institution's 2025 catalog failed to include a description of the instruction provided in each of the courses offered by the institution.
		Correction: The institution shall update its catalog to include description of the instruction provided in each of the courses offered by the institution, pursuant to CEC § 94909 (a)(5).

		Correction: The institution shall either provide proof of the documentation submitted to the Bureau's Licensing Unit for the approval to update the total number of hours required for completion for the Advanced Medical Coding program to 160 hours.
		If the institution did not receive approval from the Bureau to update the Advanced Medical Coding program hours to 160 hours, the institution must contact the Bureau's Licensing Unit at BPPE.Licensing@dca.ca.gov regarding information and requirements to update the Bureau's records.

		Correction: The institution shall update the statements on all sections of its website where the institution identifies it is approved by the Bureau for Private Postsecondary Education (BPPE) to include the Bureau's website (www.bppe.ca.gov), pursuant to CEC § 94913 (b).
7	CEC § 94897 (I)	Violation Description: On the institution's "Admissions" webpage (https://hsti.com/admissions/) under FAQ section titled "Is HealthStaff Training Institute accredited?" and "Is HealthStaff Training Institute approved by the Bureau for Private Postsecondary Education (BPPE)?", and on the Phlebotomy Technician webpage (https://hsti.com/phlebotomy-technician-i/) Under FAQ section titled "Is the Phlebotomy Technician Course accredited?", the institution states it is approved to operate by Bureau for Private Postsecondary Education (BPPE), however the institution failed to define the term approved to operate.
		Correction: The institution shall update the statements on its website, where the institution identifies it is approved by the Bureau for Private Postsecondary Education (BPPE) to state, "BPPE APPROVED - Approval to Operate means compliance with state standards as set forth in the California Private Postsecondary Education Act of 2009".

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.
