1	CEC § 94913 (a)(2)&(5)	Violation Description: The institution's website fails to contain School Performance Fact Sheet for each educational program offered by the institution and most recent annual report submitted to the bureau. Correction: The institution shall update the website to include all required items pursuant to CEC § 94913(a)(2)&(5).
2	CEC § 94909 (a)(3)(D)	Violation Description: The institution's catalog fails to contain the required OSAR statement. <i>"The Office of Student Assistance and Relief is available to support prospective students, current students, or past students of private postsecondary educational institutions in making informed decisions, understanding their rights, and navigating available services and relief options. The office may be reached by calling (888) 370-7589, option #5 or by visiting osar.bppe.ca.gov"</i>

		Correction: The institution shall update the catalog to include the required OSAR statement pursuant to CEC § 94909 (a)(3)(D).
4	CEC § 94911(c)	Violation Description: The institution's enrollment agreement does not contain the following statements underlined and in capital letters on the same page as the student's signature. <u>TOTAL CHARGES FOR THE CURRENT PERIOD OF ATTENDANCE</u> <u>THE ESTIMATED TOTAL CHARGES FOR THE ENTIRE EDUCATIONAL PROGRAM</u> <u>THE TOTAL CHARGES THE STUDENT IS OBLIGATED TO PAY UPON ENROLLMENT.</u> Correction: The institution shall include on its enrollment agreement the above statements underlined and in capital letters on the same page as the student's signature pursuant to CEC § 94911(c).
5	CEC §94911(e)(2)	Violation Description: The institution's enrollment agreement fails to the required disclosure: The institution's refund policy and a statement that, if the student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds. Correction: The institution shall update the enrollment agreement to include the required disclosure pursuant CEC §94911(e)(2).
6	CEC §94911(f)	Violation Description: The institution's enrollment agreement fails to include the required information that if the student obtains a loan to pay for an educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund. Correction: The institution shall update the enrollment agreement to include the required information pursuant to CEC §94911(f)

7	CEC §94911(g)(1) & (2)	Violation Description: The institution's enrollment agreement fails to include the required information that if the student is eligible for a loan guaranteed by the federal or state government and the student defaults on the loan, both of the following may occur: (1) The federal or state government or a loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan. (2) The student may not be eligible for any other federal student financial aid at another institution or other government assistance until the loan is repaid. Correction: The institution shall update the enrollment agreement to include the required information pursuant to CEC §94911(g)(1) & (2)
8	5 CCR §71930(e)	Violation Description: The institution was unable to immediately make available the CAO job description information upon request. Correction: The institution shall update the CAO file as well as provide the CAO job description document for review pursuant to 71930(e)

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.
