1	CEC § 94909 (a)(3)(D)	<p>Violation Description: The institution's 2024-2025 catalog, failed to contain the required verbatim statement: "The Office of Student Assistance and Relief is available to support prospective students, current students, or past students of private postsecondary educational institutions in making informed decisions, understanding their rights, and navigating available services and relief options. The office may be reached by calling (888) 370-7589 or by visiting https://www.osar.bppe.ca.gov/."</p> <p>Correction: The institution shall update its 2025 catalog, to include the above-mentioned statement pursuant to CEC § 94909 (a)(3)(D).</p>
2	CEC § 94909 (a)(5)	<p>Violation Description: On page 60 institution's 2024-2025 catalog, the total clock hours and total credits to complete the Associate Of Science In Diagnostic Medical Sonography program does not match Bureau records.</p>

		<p>Correction: To remedy this violation, the institution shall either provide proof of the documentation submitted to the Bureau's Licensing Unit for the approval to update the total number of clock hours and total credit hours to complete the Associate Of Science In Diagnostic Medical Sonography program to 1665 total clock hours and 73 credit hours. If the institution did not notify Bureau's Licensing Unit of the change in program hours, the school may contact the Bureau's Licensing Unit at BPPE.Licensing@dca.ca.gov regarding information and requirements to update Bureau records.</p> <p>OR if the Bureau's records are correct the institution shall update the 2024-2025 catalog to the 1710 total clock hours and 77 credit hours to complete the Associate Of Science In Diagnostic Medical Sonography program.</p>
3	5 CCR § 71800 (d)	<p>Violation Description: The institution's enrollment agreements failed to contain the date by which the student must exercise his or her right to cancel or withdraw.</p> <p>Correction: The institution shall update its enrollment agreement to include the date by which the student must exercise his or her right to cancel or withdraw pursuant to 5 CCR § 71800 (d).</p>
4	5 CCR § 71800 (e)(11) in conjunction with 5 CCR § 76120 (a)	<p>Violation Description: The institution's enrollment agreements incorrectly identify the STRF fee on page 16, as " \$2.50 per \$1,000 of institutional charges". The current fee is listed as "\$0.00 per \$1,000 of institutional charge."</p> <p>Correction: The institution shall update its enrollment agreement, to include the current STRF value pursuant to 5 CCR § 71800 (e)(11) in conjunction with 5 CCR § 76120 (a).</p>

5	CEC § 94911 (f)	<p>Violation Description: The institution's enrollment agreements failed to contain a statement specifying that, if the student obtains a loan to pay for an educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund.</p> <p>Correction: The institution shall update its enrollment agreements to include the above-mentioned statement, pursuant to CEC § 94911 (f).</p>
6	CEC § 94911 (j)(1)	<p>Violation Description: Although the institution's enrollment agreements contain the specific required statement directing students to the Bureau for unanswered questions, the statement does not contain the most recent address for the Bureau.</p> <p>Correction: The institution shall update its enrollment agreements to include the above-mentioned address in the statement, pursuant to CEC § 94911 (j)(1).</p>
7	CEC § 94902 (a)	<p>Violation Description: The institution's enrollment agreements failed to contain a space for the institutional representative to date the enrollment agreement alongside the signature.</p> <p>Correction: The institution shall update its enrollment agreements to include the above-mentioned space for institutional representative to date the enrollment agreement alongside the signature, pursuant to CEC § 94902 (a).</p>
8	CEC § 94913 (a)(1)	<p>Violation Description: The homepage of the institution's website failed to post the most current catalog.</p> <p>Correction: Once the institution's catalog has been updated to remedy the violations, the institution shall update its website to provide the current/updated school catalog pursuant to CEC § 94913 (a)(1).</p>

9	CEC § 94913 (a)(5)	<p>Violation Description: The institution failed to post on its website clear and conspicuous links to the school's The institution's most recent annual report submitted to the bureau.</p> <p>Correction: The institution shall update its website to include a clear and conspicuous link to the school's 2022 annual report pursuant to CEC § 94913 (a)(5).</p>
10	CEC § 94897 (I)	<p>Violation Description: On every page of the institution's website, the institution defines itself as, "Accredited" by the Bureau. This statement is not compliant with CEC § 94897 (i)(1), as the institution is not affiliated with the Bureau.</p> <p>Correction: The institution shall update its website where the institution identifies it is approved by the California Bureau for Private Postsecondary Education to state, "BPPE APPROVED – Approval to Operate means compliance with state standards as set forth in the California Private Postsecondary Education Act of 2009".</p>
11	CEC § 94897 (i)(1)	<p>Violation Description: On every page of the institution's website, the institution defines itself as, "Accredited" by the Bureau. This statement is not compliant with CEC § 94897 (i)(1), as the institution is not affiliated with the Bureau.</p> <p>Correction: The institution shall update its website to remove the "Accreditation" language pursuant to CEC § 94897 (i)(1).</p>
12	5 CCR § 76140	<p>Violation Description: The institution's 2025 1st and 2nd Quarter STRF supporting documentation failed to contain record of the student's (5) Address at the time of enrollment, (6) Home address, (7) Date enrollment agreement signed, (11) Third-party payer identifying information, and (13) Total institutional charges paid.</p> <p>Correction: The institution shall update the institution's 2025 1st and 2nd Quarter STRF supporting documentation, pursuant 5 CCR § 76140 (a).</p>

Violation	Code Section Violated	Description of the violation and required correction.
13	5 CCR § 71760	<p>Violation Description: The institution failed to develop and maintain adequate procedures used by the institution to assure that it is maintained and operated in compliance with the Act and this Division.</p> <p>Correction: The institution shall update its policies and procedures to include the above-mentioned self-monitoring policy pursuant to 5 CCR § 71760.</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.
