Violation	Code Section Violated	Description of the violation and required correction.
1	CEC § 94909 (a)(9)	Violation Description: Page 47 of the institution's catalog contain the schedule of total charges for a period of attendance and an estimated schedule of total charges for the entire educational program, however failed to mention registration fee as non refundable charge. Correction: The institution shall update the catalog to include above information pursuant to CEC § 94909 (a)(9).
2	CEC § 94909 (a)(8)(B)	Violation Description: Pages 50 of the institution's catalog contains the cancellation, withdrawal and refund policies, however failed to contain the complete cancellation statement. Correction: The institution shall update the institution's catalog with the above information, pursuant to CEC § 94909 (a)(8)(B).

Violation	Code Section Violated	Description of the violation and required correction.
3	CEC § 94909 (a)(3)(D)	Violation Description: The institution catalog failed to include the following disclosure: “The Office of Student Assistance and Relief is available to support prospective students, current students, or past students of private postsecondary educational institutions in making informed decisions, understanding their rights, and navigating available services and relief options. The office may be reached by calling (888-370-7589) or by visiting (www.osar.bppe.ca.gov).” Correction: The institution shall update the catalog to include the Office of Student Assistance and Relief disclosure, pursuant to CEC § 94909 (a)(3)(D).
4	CEC § 94909 (a)(2)	Violation Description: Page 3 of the institution's catalog contain a statement that the institution is a private institution and approved to operate by the Bureau, however failed to contain complete approval statement. Correction: The institution's catalog shall contain the above information, pursuant to CEC § 94909 (a)(2).
5	5, CCR § 71800 (a)	Violation Description: The institution's enrollment agreement failed to include the addresses where instruction will be provided. Correction: The institution shall update the enrollment agreement to include the above information, pursuant to 5, CCR § 71800 (a).
6	CEC § 94911 (e)(2)	Violation Description: The enrollment agreement failed to include the disclosure that if the student has received federal student financial aid funds, the student is entitled to refund of moneys not paid from federal student financial aid program funds. Correction: The institution shall update the enrollment agreement to include the above information, pursuant to CEC § 94911 (e)(2).
7	CEC § 94913 (a)(1)	Violation Description: The institution's website failed to update a link to the institution's current catalog. Correction: The institution shall update the institution's website, pursuant to CEC § 94913 (a)(1).

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.
