1	5 CCR § 71810 (b)(7)	Violation Description: The institution's 2025-2026 catalog failed to contain the institution's policies and procedures for the award of credit for prior experiential learning, including assessment policies and procedures, provisions for appeal, and all charges that a student may be required to pay. Correction: The institution shall update their 2025-2026 catalog to include the above statements, pursuant to 5 CCR § 71810 (b)(7).
2	5 CCR § 71810 (b)(15) in conjunction with 5 CCR § 71930 (b)(1)	Violation Description: The institution's 2025-2026 catalog failed to contain policies on the retention of student records that reflect the requirements to maintain student records for five years and transcripts permanently. Correction: The institution shall update their 2025-2026 catalog to include the above statements, pursuant to 5 CCR § 71810 (b)(15) in conjunction with 5 CCR § 71930 (b)(1)

3	5 CCR § 71800 (e)(5)	<p>Violation Description: The institution's enrollment agreement failed to itemize the cost for textbooks.</p> <p>Correction: The institution shall update their enrollment agreement to include the itemization for cost of textbooks, pursuant to 5 CCR § 71800 (e)(5).</p>
4	CEC § 94913 (a)(1)	<p>Violation Description: Following correction of the above catalog violations, the institution's website will no longer include a copy, or link to, their most recent catalog.</p> <p>Correction: The institution shall update their website to include a copy, or link to their current catalog, pursuant to CEC § 94913 (a)(1).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.
