Elizabeth Elias issues this citation in her official capacity as Deputy Bureau Chief of Enforcement at the Bureau for Private Postsecondary Education, California Department of Consumer Affairs (hereinafter referred to as the “Bureau”).

LICENSING HISTORY

1. On or about December 19, 2023, the Bureau issued an Approval to Operate an Accredited Private Postsecondary Institution, Institution Code 3008411 to Asian American International Beauty College, hereinafter referred to as the “Institution.” This Approval to Operate expired on or about May 31, 2025, and has not been renewed. An application for renewal of the Institutions Approval to Operate an Accredited Private Postsecondary Institution was received on April 8, 2025, and is under review.

CITATION JURISDICTION

3. This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

CAUSE FOR CITATION & ASSESSMENT OF FINE AND/OR ORDER OF ABATEMENT

4. The Institution is in violation of the following Bureau laws and regulations:

<p>Violation #1:</p> <p>5 CCR section 74112(m)(1-9) Uniform Data – Annual Report, Performance Fact Sheet and 5 CCR section 71930(e) – Maintenance of Records</p>
<p>Cause for Citation: On or about May 20, 2025, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff requested documentation supporting data reported on the Institutions 2022/2023 School Performance Fact Sheet (SPFS). Upon review, Bureau staff found that the Institution failed to collect and/or maintain all required data points pursuant to 5 CCR section 74112 for 2022. Although the Institutions supporting documentation for 2023 contained column headers, some of the required fields did not contain data, specifically subsections (m)(4) all written communication with employer verifying student's employment or salary, subsection (m)(6), and subsection (m)(9) copies of notes, letters or emails through which the information was requested and gathered.</p>
<p>Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.</p>
<p>Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:</p> <p>The Bureau orders the Institution to correct the violation by providing an electronic copy of the template used by the Institution to document supporting data for SPFS, for the Bureau to verify the Institution is collecting the required data points pursuant to 5 CCR section 74112.</p> <p>In addition, the Institution must submit a statement of attestation they have corrected the violation and will ensure that the supporting data for SPFS is collected and maintained and immediately available during an inspection. The statement of attestation must be dated and signed by an authorized representative of the Institution.</p>

Violation #2:

CEC section 94902(b)(1) and (b)(3) – General Enrollment Requirements and CEC section 94912 – Signature, Initials Required

Cause for Citation: On or about May 20, 2025, the Bureau conducted an unannounced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff reviewed three current student files and found each file reviewed contained a School Performance Fact Sheet (SPFS) for a 1600-hour Cosmetology Program, rather than a SPFS for the 1000-hour Cosmetology Program for which the students enrolled in.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class C” violation. The Institution is issued a fine of \$1,000.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to ensure all student records follow the law pursuant to CEC sections 94902 and 94912. The Institution must submit a statement of attestation that they have corrected the violation and will ensure that all students sign a SPFS for the program they are enrolling in and that student records contain signed and dated SPFS. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Violation #3:

CEC section 94935(b) and (h) – Notice to Comply and 5 CCR section 75010(h) - Notice to Comply; Informal Appeal Process

Cause for Citation: On or about April 17, 2024, Bureau staff issued a Notice to Comply (NTC) to the Institution. The Institution failed to correct some of the cited violations within the required 30-day period. The following violations from the NTC remain uncorrected:

- **Violation 14** - CEC section 94913(a)(2) – Institutional Web Site Requirements

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class B” violation. The Institution is issued a fine of \$2,500.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violations identified in the Notice to Comply and submit proof of compliance pursuant to CEC section 94913 and 94897.
