LICENSING HISTORY

1. On or about August 12, 2022, the Bureau issued an Approval to Operate a Private Postsecondary Institution to California Institute of Career Development (hereinafter referred to as the "Institution"). This Approval to Operate will expire on or about August 12, 2027, unless renewed.

DISCIPLINE HISTORY

2. The Institution has no prior discipline history.

3. This administrative citation is issued to the Institution pursuant to the statutory provisions of California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

hearing. If the Institution has not requested to withdraw the hearing, a hearing will be set to hear the matter.

The Bureau may also enforce the administrative fine as if it were a money judgment pursuant to CEC section 94936.
