Elizabeth Elias issues this affirmed citation in her official capacity as Deputy Bureau Chief of Enforcement at the Bureau for Private Postsecondary Education, California Department of Consumer Affairs (hereinafter referred to as the "Bureau").

### LICENSING HISTORY

1. On or about September 17, 2018, the Bureau renewed an Approval to Operate a Private Postsecondary Institution, Institution Code 90285787, to East Valley College, hereinafter referred to as the "Institution." This Approval to Operate expired on or about September 17, 2023, and is pending renewal. An application for renewal of the Institution's Approval to Operate a Private Postsecondary Institution was received on September 18, 2023, and is under review.

#### **DISCIPLINE HISTORY**

2. The Institution has no prior discipline history.

## CITATION JURISDICTION

3. This administrative citation is issued to the Institution pursuant to the statutory provisions of California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

#### CITATION HISTORY

4. On or about May 13, 2025, the Bureau issued Citation No. 24250279. On or about May 27, 2025, the Bureau received an appeal with a request for an informal conference. The informal conference was held on July 9, 2025. No new substantive facts were presented during the informal conference; therefore, the Bureau affirms Citation No. 24250279.

# CAUSE FOR CITATION & ASSESSMENT OF FINE AND/OR ORDER OF ABATEMENT

5. The Institution is in violation of the following Bureau laws and regulations:

### Violation #1:

CEC section 94935(b) – Notice to Comply and 5 CCR section 75010(h) - Notice to Comply; Informal Appeal Process

**Cause for Citation** On or about June 28, 2024, the Bureau conducted an announced compliance inspection pursuant to CEC section 94932.5(a). At the conclusion of the inspection, Bureau staff issued a Notice to Comply for the following violations:

- CEC section 94913(a)(4); (a)(5) Institutional Web Site Requirements
- 5 CCR section 71760 Self-Monitoring Procedures

The Institution failed remedy the noncompliance as noted in the Notice to Comply within 30 days.

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class B" violation. The Institution is issued a fine of \$2,500.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violations identified in the Notice to Comply and submit proof of compliance pursuant to CEC section 94935.

## Violation #2:

# 5 CCR section 76140 - Record-Keeping Requirements and 5 CCR section 71930 (e) – Maintenance of Records

**Cause for Citation:** On or about June 28, 2024, the Bureau conducted an announced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff requested the Institution's Student Tuition Recovery Fund (STRF) substantiating data for the 4<sup>th</sup> quarter reporting period of 2023 and the 1<sup>st</sup> quarter reporting period of 2024. The Institution was unable to provide the required STRF supporting documents upon request pursuant to 5 CCR section 76140.

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class B" violation. The Institution is issued a fine of \$1,001.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violation by providing an electronic copy of the template used by the Institution to document its STRF substantiating documentation, for the Bureau to verify the Institution is collecting the required data points pursuant to 5 CCR section 76140.

In addition, the Institution must submit a statement of attestation they have corrected the violation and will ensure that the substantiating data for STRF is maintained in an electronic format and readily available to a Bureau representative upon request per 5 CCR 76140. The statement of attestation must be dated and signed by an authorized representative of the Institution.

# Violation #3:

5 CCR section 74112(m)(1-9) – Uniform Data – Annual Report, Performance Fact Sheet and 5 CCR section 71930(e) – Maintenance of Records

**Cause for Citation:** On or about June 28, 2024, the Bureau conducted an announced compliance inspection pursuant to CEC section 94932.5(a). Bureau staff requested documentation supporting all data reported on the Institutions 2021/2022 School Performance Fact Sheet (SPFS). Bureau staff

found that the Institution failed to collect the required data pursuant to 5 CCR section 74112 and therefore was unable to make the documentation immediately available for inspection.

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to correct the violation by providing an electronic copy of the template used by the Institution to document supporting data for SPFS, for the Bureau to verify the Institution is collecting the required data points pursuant to 5 CCR section 74112.

In addition, the Institution must submit a statement of attestation they have corrected the violation and will ensure that the supporting data for SPFS is maintained and immediately available during an inspection. The statement of attestation must be dated and signed by an authorized representative of the Institution.

# Violation #4:

CEC 94900.5(b) – Required Institutional Records and 5 CCR section 71930(a) and (e) – Maintenance of Records

**Cause for Citation:** On or about June 28, 2024, the Bureau conducted an announced compliance inspection pursuant to CEC 94932.5(a). Bureau staff reviewed faculty records and determined that that the Institution did not maintain faculty records regarding continuing education (CE) courses in the subject area, classroom management or other courses related to teaching.

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class C" violation. The Institution is issued a fine of \$1,000.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to ensure all faculty records follow the law pursuant to CEC 94900.5(b) and 5 CCR section 71930(a) and (e). The Institution must submit a statement of attestation they have corrected the violation and ensured that all faculty records are compliant with the law. The statement of attestation must be dated and signed by an authorized representative of the Institution.

### Violation #5:

# 5 CCR Section 71770(a)(1) – Admission Standards and Transferred Credits Policy

Cause for Citation: On or about June 28, 2024, the Bureau conducted an announced compliance inspection pursuant to CEC section 94932.5 (a). Bureau staff reviewed three current, three graduated, and three withdrawn/dropped student files. The Institution failed to maintain admissions documentation (i.e., high school diploma or its equivalent, or otherwise meet the institution's criteria for a qualified candidate for admission, including minimum levels of prior education, preparation, skills, or training) indicating the student had a reasonable prospect of completing the program.

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a statement of attestation they have corrected the violation and will maintain admissions documentation pursuant to 5 CCR section 71770. The statement of attestation must be dated and signed by an authorized representative of the Institution.

# Violation #6:

5 CCR section 71920(b)(3) – Student Records, 5 CCR section 71930(a) and (e) – Maintenance of Records, CEC section 94900.5(c) – Required Institutional Records and CEC section 94902(b)(3) - General Enrollment Requirements

Cause for Citation: On or about June 28, 2024, the Bureau conducted an announced compliance inspection pursuant to CEC section 94932.5 (a). Bureau staff reviewed three current, three graduated, and three withdrawn/dropped student files. Bureau staff determined that none of the files reviewed contained a signed School Performance Fact Sheet (SPFS), a general enrollment requirement. The Institution stated that they were unaware of the requirement.

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class B" violation. The Institution is issued a fine of \$1,001.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to ensure all student records are maintained pursuant to 5 CCR sections 71920, 71930 and CEC sections 94900.5 and 94902. The Institution must submit a statement of attestation that they have corrected the violation and will ensure that all student records contain signed and dated SPFS prior to the execution of the enrollment agreement. The statement of attestation must be dated and signed by an authorized representative of the Institution.

#### Violation #7:

5 CCR section 74110 – Annual Report and CEC section 94934 – Annual Report

**Cause for Citation:** A review of the Bureau's records confirm the Institution failed to submit a 2023 Annual Report. The report was due to the Bureau by December 1, 2024.

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$5,000.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit the 2023 Annual Report pursuant to 5 CCR section 74110 and CEC section 94934.

#### COMPLIANCE WITH ORDER OF ABATEMENT

- 6. In accordance with the provisions of CEC section 94936 and 5 CCR sections 75020 and 75040, the Bureau issues the order(s) of abatement described above. Evidence of compliance with the order of abatement must be submitted to the Bureau within 30 days from the date of issuance of this affirmed citation. ### **COMPLIANCE WITH ASSESSMENT OF FINE**

7. In accordance with the provisions of CEC section 94936, and 5 CCR section 75020 et seq., the Bureau hereby orders this assessment of fines in the total amount of \$15,504.00 for the violations described above. Payment of the fines must be made to the Bureau within 30 days from the date of issuance of this affirmed citation. To assist the Bureau in processing the payment of fines, please submit the enclosed Payment of Fine – Waiver of Appeal form.

#### NOTICE OF APPEAL RIGHTS

8. Pursuant to 5 CCR section 75040(d), the affirmed decision is considered final, unless a request for a hearing was filed timely.

If the Institution requested a hearing and no longer chooses to proceed with the hearing, the Institution may request to withdraw the request for a

hearing. If the Institution has not requested to withdraw the hearing, a hearing will be set to hear the matter.

# COMPLIANCE WITH FINE AND/OR ORDER OR ABATEMENT DISCLOSURE

9. Pursuant to 5 CCR section 75050, payment of fine and/or compliance with any order of abatement does not constitute an admission of the violation charged and shall be represented as satisfactory resolution of the matter for the purposes of public disclosure.

Pursuant to 5 CCR section 75050, failure to comply with this citation order, its order of abatement, and/or administrative fine by the required due date is grounds for denial or discipline of an approval to operate. Where a citation is not contested and fine is not paid, the full amount of the assessed fine shall be added to the fee for renewal of the approval to operate. An approval to operate shall not be renewed without payment of the renewal fee and fine. The Bureau may also enforce the administrative fine as if it were a money judgment pursuant to CEC section 94936.
