Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

<u>CITATION</u>

A Citation is hereby issued to Scripcar Inc., 49% Owner of The Acting Corps (Institution) located at 5502 Cahuenga Blvd., North Hollywood, CA 91601 pursuant to Business and Professions Code section 125.9; California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 for the violations described below.

BACKGROUND

Pursuant to CEC section 94923(a) the Student Tuition Recovery Fund relieves or mitigates economic loss suffered by a student while enrolled in an institution not exempt from this article pursuant to Article 4 (commencing with section 94874), who, at the time of his or her enrollment, was a California resident or was enrolled in a California residency program, prepaid tuition, and suffered economic loss.

All institutions are required to submit a Student Tuition Recovery Fund (STRF) Assessment Reporting Form to the Bureau no later than the last day of the month following the close of the quarter.

The Bureau sends notifications/reminders to all approved institutions 30 days prior to close of each quarter. As of November 21, 2018, The Acting Corps, Institution code 97715583 has not submitted the STRF Assessment Reporting Form(s) for 4th quarter of 2015, the 2nd and 4th quarters of 2016, the 1st quarter of 2017, and the 2nd quarter of 2018.

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **November 21, 2018.** Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **December 21, 2018.** Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until **30** days after a final order is entered against you.
