1	CEC § 94913 (a)(2)&(5)	Violation Description: The institution's website fails to contain School Performance Fact Sheet for each educational program offered by the institution and most recent annual report submitted to the bureau. Correction: The institution shall update the website to include all required items pursuant to CEC § 94913(a)(2)&(5)..
2	CEC § 94909(a)(8)(A)	Violation Description: The institution's catalog fails to include required information regarding articulation agreements between the institution and any other college or university that provides for the transfer of credits earned in the program of instruction. If the institution has not entered into an articulation or transfer agreement with any other college or university, the institution shall disclose that fact. Correction: The institution shall update the catalog to include the required information regarding articulation agreements pursuant to 5CCR § 94909(a)(8)(A).

3	CEC § 94909(a)(10)	Violation Description: The institution's catalog fails to include required information reporting whether the institution participates in state financial aid programs. Correction: The institution shall update the catalog to include the required information for state financial aid programs pursuant to 5CCR § 94909(a)(10)
4	5CCR § 71810(b)(13)(A)	Violation Description: The institution's catalog fails to include the required housing information statement of whether the institution has dormitory facilities under its control. Correction: The institution shall update the catalog to include all the required housing information pursuant to 5CCR § 71810(b)(13)(A).

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.
