22 1. On or about September 12, 2017, Complainant Leeza Rifredi, Deputy Bureau Chief  
23 of the Bureau for Private Postsecondary Education, Department of Consumer Affairs ("Bureau"),  
24 filed Statement of Issues No. 1002167 solely in her official capacity.

25 2. On or about April 3, 2012, the Bureau received an Application for Renewal of  
26 Approval to Operate and Offer Educational Programs for Non-Accredited Institutions from  
27 California American University ("Respondent"). The Bureau denied the Application on  
28 September 8, 2016. Respondent timely appealed.
