1	CEC § 94897(l)	<p>Violation Description: The institution’s website uses the statement “approved by BPPE” which is not compliant with CEC § 94897(l).</p> <p>Correction: The institution shall correct the language on it’s website to meet the requirement of CEC § 94897(l) and shall state:</p> <p><i>“BPPE APPROVED - Approval to Operate means compliance with state standards as set forth in the California Private Postsecondary Education Act of 2009.”</i></p>
2	CEC § 94909(a)(3)(A)	<p>Violation Description: The institution’s 2023 Course Catalog (01/01/2023 to 12/31/2023) fails to include the correct address for the Bureau in the disclosure statement on pg. 4.</p> <p>Correction: The institution shall update the required disclosure statement with the Bureau’s current address:</p> <p>1747 North Market Blvd. Ste. 225 Sacramento CA 95834</p>

3	5 CCR § 71810(b)(15) referencing CEC § 94900(b)	<p>Violation Description: The institution's 2023 Course Catalog (1/1/2023 – 12/31/2023) policy on student record retention is not consistent with CEC § 94900 (b), which states that permanent records must be maintained for the following:</p> <ul style="list-style-type: none"> (1) The degree or certificate granted and the date on which that degree or certificate was granted. (2) The courses and units on which the certificate or degree was based. (3) The grades earned by the student in each of those courses <p>Correction: The institution's policy on student record retention shall be updated to be consistent with CEC § 94900 (b).</p>

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
