22 1. On or about September 18, 2017, Joanne Wenzel, former Chief of the Bureau for  
23 Private Postsecondary Education, Department of Consumer Affairs (Bureau), filed Statement of  
24 Issues No. 1002107 solely in her official capacity:


25 2. On or about May 17, 2013, the Bureau for Private Postsecondary Education (Bureau)  
26 received an Application for Renewal of Approval to Operate an Institution Non-Accredited from  
27 Career Advancement Solutions (Respondent). Between June 6, 2013 and August 19, 2016, the  
28 Bureau and Respondent exchanged correspondence regarding Respondent's application. On or

1 about July 8, 2016, the Bureau issued to Respondent a letter explaining the deficiencies in its  
2 application. On or about August 19, 2016, the Bureau received a response from Respondent. On  
3 or about September 9, 2016, the Bureau issued to Respondent a Notice of Denial of Application  
4 for Renewal of Approval to Operate. On or about September 20, 2016, the Bureau received a  
5 request for an administrative hearing from Respondent.

6 3. The basis for withdrawing the pending Statement of Issues No. 1002107 is that  
7 Respondent has now provided the documents and other information necessary for its renewal of  
8 approval to operate.

9 4. WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No.  
10 1002107 is hereby withdrawn without prejudice.
