Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

#### **CITATION**

A Citation is hereby issued to Capital Equity Partners Inc, Owner of TCA Business Institute located at 1455 South Auto Center Drive, Suite 125, Ontario, CA 91761 pursuant to Business and Professions Code section 125.9; California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 for the violations described below.

#### BACKGROUND

Pursuant to CEC section 94923(a) the Student Tuition Recovery Fund relieves or mitigates economicloss suffered by a student while enrolled in an institution not exempt from this article pursuant to Article 4 (commencing with section 94874), who, at the time of his or her enrollment, was a California resident or was enrolled in a California residency program, prepaid tuition, and suffered economic loss.

All institutions are required to submit a Student Tuition Recovery Fund (STRF) Assessment Reporting Form to the Bureau no later than the last day of the month following the close of the quarter.

The Bureau sends notifications/reminders to all approved institutions prior to close of each quarter. As of April 26, 2018, TCA Business Institute, Institution code 1937371 has not submitted the STRF Assessment Reporting Form for the 4<sup>th</sup> quarter for 2015 and 1<sup>st</sup> and 4<sup>th</sup> quarters for 2017.

Pursuant to CEC Section 94930.5 (d)(1)(A). An annual fee for each campus designated by the Institution as a main campus location in California, in an amount equal to 0.45 percent of the

	(5) Total amount of institutional charges after rounding each student's institutional charges to the nearest \$1,000, for all eligible STRF students whose STRF assessment was collected in the reporting period; and

Ontario, CA 91761, that the STRF Assessment Reporting Form for the 4<sup>th</sup> quarter of 2015 was due. As of April 26, 2018, the Bureau has not received the STRF Assessment Reporting Form from the Institution.

On April 3, 2017, the Institution was notified via mail at 1455 South Auto Center Drive, Suite 125, Ontario, CA 91761, that the STRF Assessment Reporting Form for the 1<sup>st</sup> quarter of 2017 was due. As of April 26, 2018, the Bureau has not received the STRF Assessment Reporting Form from the Institution.

On January 2, 2018, the Institution was notified via mail at 1455 South Auto Center Drive, Suite 125, Ontario, CA 91761, that the STRF Assessment Reporting Form for the 4<sup>th</sup> quarter of 2017 was due. As of April 26, 2018, the Bureau has not received the STRF Assessment Reporting Form from the Institution.

## Order of Abatement:

The Bureau orders that the Institution submit the delinquent STRF Assessment Reporting Forms with the STRF Assessments collected from students for the quarters listed above. The Institution shall also submit the student information to substantiate the data reported on the STRF Assessment Reporting Form(s). The information provided shall comply with "Record Keeping Requirements" Pursuant to 5, CCR section 76140.

# 5, CCR Section 74006(a) and (b) - Annual Fee

"(a) An institution's annual fee is due within 30 days of the date on which the institution originally receives its approval to operate and each year thereafter on the anniversary of the date of the original approval. (b) An institution shall pay its annual fee in addition to any other applicable fees.

# CEC 94930.5 (d)(1)(A) and/or(B) if applicable - Fee Schedule

The Bureau orders the Institution to submit its annual fee for 2017 in accordance with 5, CCR section 74006(a)(b) and CEC section 94930.5(d)(1)(A). In addition, the Institution must pay all late payment penalty fees.
