On November 15, 2019, an informal telephone conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No. 1920108 (Citation) against Ambreen Kazmi and Mutahir Kazmi, Owners of Adroit School of Architecture (Institution). In attendance were Beth Danielson, Enforcement, Chief, and Ambreen Kazmi, Owner.

Pursuant to Business and Professions Code, section 125.9; California Education Code, section 94936; and Title 5 of the California Code of Regulations, section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 1920108.

Reason for Modification: New substantive facts were presented at the conference. The Order of Abatement has been satisfied.
