20 Postsecondary Education, Department of Consumer Affairs (Bureau), filed Statement of Issues  
21 No. 999947 solely in her official capacity.


22 2. On or about January 11, 2012, the Bureau for Private Postsecondary Education  
23 (Bureau) received an Application for Renewal of Approval to Operate an Institution Non-  
24 Accredited from Micro-Easy Vocational Institute, Kola Onafowode, Owner (Respondent). On or  
25 about August 20, 2013 and October 18, 2013, the Bureau issued to Respondent letters explaining  
26 the deficiencies in its application. On or about August 4, 2014, the Bureau received a response  
27 from Respondent. On or about August 18, 2014, the Bureau issued to Respondent a Notice of

1 Denial of Application for Renewal of Approval to Operate. On or about September 8, 2014,  
2 Respondent sent the Bureau a letter requesting an administrative hearing.

3 3. The basis for withdrawing the pending Statement of Issues No. 999947 is that  
4 Respondent has now provided the documents and other information necessary for its renewal of  
5 licensure.

6 4. WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No. 999947  
7 is hereby withdrawn without prejudice.
