## LICENSING HISTORY

1. On or about February 22, 2018, the Bureau renewed an Approval to Operate a Private Postsecondary Institution to Precise Barber College (hereinafter referred to as the "Institution"). This Approval to Operate expired on or about February 22, 2023, and has not been renewed. An Application for Renewal of the Institution's Approval to Operate a Private Postsecondary Institution was received on March 3, 2023, and is under review.
