LICENSING HISTORY

1. On or about May 17, 2017, the Bureau renewed an Approval to Operate a Private Postsecondary Institution to Zoom Graphics (hereinafter referred to as the "Institution"). This Approval to Operate expired on or about May 17, 2022, and has not been renewed. An application for renewal of the Institution's Approve to Operate a Private Postsecondary Institution was received on March 21, 2022, and is under review.
