Connie Bouvia issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Enforcement Chief of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

#### BACKGROUND

Nurse Builders Academy (Institution), Institution Code 25448447, was issued a Notice to Comply #000354 (NTC) on March 24, 2012 as a result of minor violations that were detected during the desk and on-site inspection. A notice of disagreement was received by the Bureau and an informal conference was held. On June 13, 2012 a 'Notice to Comply Appeal – Informal Office Conference Decision' was issued affirming the NTC. The owners of the Institution failed to submit a declaration and evidence of compliance for the cited violations within 30 days from the date of the decision. The violations still remain outstanding.

#### **CITATION**

A Citation is hereby issued to Adriano Naderi, Masood Naderi, John Keyashian, and Christine Bui, owners of Nurse Builders Academy located at 1825 De La Cruz Blvd., Ste. 105, Santa Clara, CA 95050 in accordance with Section 125.9 of the Business and Professions Code; Section 94936 of the California Education Code; and Section 75020 of the California Code of Regulations for the violation described in the 'Violation Code Sections' of this document.

#### PENALTY – ASSESSMENT OF A FINE

In accordance with California Education Code section 94936; and California Code of Regulations Sections 75020 and 75030, the Bureau hereby orders the issuance of a Citation and the assessment of a fine in the amount of **\$501.00** for the violations described in the 'Violation Code Sections' of this document.

You are hereby notified that you are in violation of the California Code of Regulations and cause for issuance of a citation and assessment of an administrative fine exists.

### ORDER OF ABATEMENT
