1. On or about November 21, 2022, the Bureau renewed an Approval to Operate a Private Postsecondary Institution to KZ Academy (hereinafter referred to as the "Institution"). This Approval to Operate will expire on or about November 21, 2027, unless renewed.

Cause for Citation: A review of the Bureau's records confirm the Institution failed to submit all components of the 2021 Annual Report which was due to the Bureau by December 1, 2022.

To date, the Bureau has not received financial statements as required.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit all components of the 2021 Annual Report, pursuant to 5 CCR section 74110 and CEC section 94934.
