On July 25, 2018, an informal telephone conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No. 1718034 (Citation) against Sam Brody, Owners of Codify Academy. In attendance were Yvette Johnson, Enforcement Chief; Sam Brody and Matt Brody, Owners, and Keith Zakarin, Attorney.

Pursuant to Business and Professions Code, section 148; California Education Code (CEC), section 94944; and Title 5 of California Code of Regulations (5, CCR), section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 1718034

It is the decision of the Enforcement Chief that on July 25, 2018 Citation No. 1718034 is <u>modified</u> and makes the following change(s):

CEC 94817.5. Approved to Operate or Approved

"Approved to operate" or "approved" means that an institution has received authorization pursuant to this chapter to offer to the public and to provide postsecondary educational programs."

CEC 94868. To Offer to the Public

"To offer to the public" means to advertise, publicize, solicit, or recruit."

CEC 94869. To Operate

"To operate" means to establish, keep, or maintain any facility or location in this state where, or from which, or through which, postsecondary educational programs are provided."

CEC 94902. General Enrollment Requirements

(a) A student shall enroll solely by means of executing an enrollment agreement. The enrollment agreement shall be signed by the student and by an authorized employee of the institution.

(b) An enrollment agreement is not enforceable unless all of the following requirements are met:

(1) The student has received the institution's catalog and School Performance Fact Sheet prior to signing the enrollment agreement.

(2) At the time of the execution of the enrollment agreement, the institution held a valid approval to operate.

(3) Prior to the execution of the enrollment agreement, the student and the institution have signed and dated the information required to be disclosed in the Student Performance Fact Sheet pursuant to subdivisions (a) to (d), inclusive, of Section 94910. Each of these items in the Student Performance Fact Sheet shall include a line for the student to initial and shall be initialed and dated by the student.

(c) A student shall receive a copy of the signed enrollment agreement, in writing or electronically, regardless of whether total charges are paid by the student.

Codify Academy is operating as an unapproved private postsecondary institution at 535 Mission Street, San Francisco, California 94105. The Institution advertises programs on its website at http://codifyacademy.com/course. The web print, dated April 17, 2018 from the website, states it is 16 weeks flexible hours, hands on classes instead of lectures in web development and JavaScript programing. On the website http://codifyacademy.com/, under the tuition tab, the Institution advertises \$8,800 total cost, \$11,000.00 is full tuition discount 20%, total tuition to be paid upon sign up. The Institution offers a payment plan month to month, \$1,000.00 per month, \$11,000.00 full tuition, 10 monthly payments with 0% interest, \$1,000.00 down upon sign up.

The Institution has raised the tuition, the web print dated February 14, 2018 from the website http://codifyacademy.com/ under the tuition tab, the Institution advertised \$6,700.00 total cost, \$8,000.00 full tuition, discount 10%, total tuition to be paid upon sign

The Institution offers a payment plan month to month, \$500.00 per month, \$8,000.00 full tuition, 14 monthly payments with 0% interest, \$1,000.00 down upon sign up. Codify Academy is operating as an unapproved Institution in violation of CEC section 94886.

Order of Abatement:

The Bureau orders that the Institution cease to operate as a private postsecondary educational institution. The Institution must discontinue recruiting or enrolling students and cease all instructional services and advertising in any form or type of media (including Internet web site http://codifyacademy.com/course/), until such time as an approval to operate is obtained from the Bureau. The Institution must disconnect all telephone service, for (415) 530-1557 and (925) 876-3287, and any other telephone numbers not identified here that are associated with Codify Academy until such time as an approval to operate is obtained from the Bureau. The Institution must provide a refund to all students enrolled at the school prior to the receiving an approval to operate from the Bureau as the enrollment agreements signed by the students are not enforceable since the school does not have a valid approval to operate. To comply with the Order of Abatement the Institution must submit a school closure plan to the Bureau pursuant to California Education Code section 94926. The Institution must provide a roster of each student currently enrolled at the Institution. The roster must include the name of the student, their contact information (including phone number, email address, and physical address), the program in which they are enrolled, the amount paid for the program, and the amount the student was refunded.

Assessment of Fine

The fine for this violation is \$100,000.00

Reason for modification: The Institution was verified as an exempt institution on June 11, 2018.

The administrative fine for this violation has been modified from \$100,000.00 to \$25,000.00.

TOTAL MODIFIED ADMINISTRATIVE FINE DUE: \$25,000.00

ORDER OF ABATEMENT

The Bureau orders that you comply with the orders described in the 'Violation Code Sections' of this document and submit evidence of compliance within <u>30 days</u> from the date of this decision.

APPEAL OF CITATION

You *do not* have the right to request another Informal Conference to appeal this modified Citation. You *do*, however, have the right to appeal this modified Citation through an Administrative Hearing, *only if* you initially requested one within 30 days from the issuance date of the original citation. A hearing before an Administrative Law Judge will be scheduled and you will be notified of the hearing date. The hearing will be held pursuant to Chapter 5 (commencing with section 11500) of Part 1 of Division 3 of Title 2 of the Government Code. If you did not initially request an Administrative Hearing within 30 days from when the original citation was issued, you can no longer request one.

If you do not wish to appeal this modified Citation you must withdraw your initial request for an Administrative Hearing, if one was made. Please complete and mail the enclosed <u>Withdrawal –</u> <u>Request for Administrative Hearing</u> within <u>**30 Days**</u> of the date of this decision.

EFFECTIVE DATE OF CITATION AND FINE ASSESSMENT

This modified Citation is effective on **July 30, 2018.** The order of abatement and payment are due by **August 29, 2018**.

Failure to abate the violation or to pay the administrative fine within the time allowed is grounds for denial of an application for an approval to operate or discipline. The Bureau will promptly take all appropriate action to enforce the Modified Citation and recover the civil penalties prescribed therein or found to be due after a hearing.
