21 1. On or about November 1, 2013, the Bureau for Private Postsecondary  
22 Education received an Application for Renewal of Approval to Operate an Institution Non-  
23 Accredited from Computer Training College, with Wha-Young Lee as the Owner  
24 (“Respondent”). On or about October 3, 2013, Wha-Young Lee certified under penalty of perjury  
25 to the truthfulness of all statements, answers, and representations in the application. The Bureau  
26 denied the application on January 28, 2016. Respondent requested an appeal of the denial.

1           2.     On or about July 5, 2016, Joanne Wenzel, Chief of the Bureau for Private  
2 Postsecondary Education, solely in her official capacity, filed Statement of Issues No. 1001487.  
3 Pursuant to Respondent's request for appeal, a hearing was scheduled for April 25, 2017 at the  
4 Office of Administrative Hearings in Los Angeles.

5           3.     The Bureau hereby withdraws Statement of Issues No. 1001487. The basis for this  
6 withdrawal is that, on April 17, 2017, the Bureau's counsel received Respondent's Notice of  
7 Withdrawal of Request for Hearing.

8           4.     WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No.  
9 1001487 is hereby withdrawn without prejudice.
