20 **TO ALL INTERESTED PARTIES:**

21 1. On or about October 5, 2016, the Bureau for Private Postsecondary Education  
22 ("Bureau") received an application for an Application for Renewal of Approval to Operate and  
23 Offer Educational Programs for Non-Accredited Institutions from Frederick W. Taylor University  
24 (Respondent). The Bureau denied the application on May 21, 2018. Respondent appealed the  
25 denial and submitted a request for administrative hearing.

26 2. On or about March 1, 2019, Dr. Michael Marion, Jr., Chief of the Bureau for Private  
27 Postsecondary Education, Department of Consumer Affairs, filed Statement of Issues No.  
28 1003602 solely in his official capacity. After initiating this action, Respondent provided

1 additional documents and information intended to resolve the issues of non-compliance in  
2 Respondent's application.

3 3. The Bureau hereby withdraws Statement of Issues No. 1003602. The basis for the  
4 withdrawal of this pleading is that Respondent has now provided the documents and other  
5 information necessary for its application for licensure to be in compliance with the law.

6 4. WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No.  
7 1003602 is hereby withdrawn without prejudice.
