LICENSING HISTORY

1. On or about January 7, 2022, the Bureau issued an Approval to Operate a Private Postsecondary Institution to Global Synergy University hereinafter referred to as the "Institution". This Approval to Operate will expire on or about January 7, 2027, unless renewed.

CITATION JURISDICTION

3. This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

CAUSE FOR CITATION & ASSESSMENT OF FINE AND/OR ORDER OF ABATEMENT

4. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

5 CCR section 76130 – Collection and Submission of Assessments

Cause for Citation: The Institution failed to submit the Student Tuition Recovery Fund (STRF) Assessment Reporting form and the collection of assessment fees as required for the 1st quarter reporting period of 2024.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class C" violation. The Institution is issued a fine of \$1,000.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit the Student Tuition Recovery Fund (STRF) Assessment Reporting form and the collection of assessment fees as required for the 1st quarter reporting period of 2024.

Violation #2:

5 CCR section 74006 (a), (b) – Annual Fee in conjunction with CEC 94931(b) – Late Payment

Cause for Citation: The Institution failed to pay its annual fee and 90-day late payment penalty fee for the 2024 calendar year.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class C" violation. The Institution is issued a fine of \$1,000.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to pay its annual fee and 90-day late payment penalty fee for the 2024 calendar year.

Violation #3:

CEC 94926 Procedures Prior to Closing, Teach-Out Plans in conjunction with 5 CCR 76240 (a)(b) Required Notices and Teach-Out Plan

Cause for Citation: On February 19, 2024, the Institution notified the Bureau of its intent to close but failed to follow the procedures pursuant to CEC 94926 and 5 CCR 76240.

On February 20, 2024, the Bureau provided the Institution the contact information for the Bureau's Closed School Unit. On March 4, 2024, the Bureau followed-up with the Institution regarding the school closure. To date, the Institution has not provided the Bureau with a complete school closure plan.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$5,000.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

If you wish to contest this citation, you may submit a written request to the Bureau or submit the enclosed Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing form within 30 days from the date of issuance of this citation.

Failure to submit a written request for an informal conference and/or administrative hearing within 30 days from the date of issuance of this citation will forfeit your ability to appeal the citation.

If a hearing is requested, you are not required to comply with this citation until a final order is entered against you.
