Christina Villanueva issues this Citation and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

CITATION

A Citation is hereby issued to International Public Safety University, Owner of International Public Safety United located at 738 S. Waterman Avenue, No. C36, San Bernardino, CA 92408 pursuant to Business and Professions Code section 125.9; California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 for the violations described below.

BACKGROUND

In accordance with CEC section 94934 and 5, CCR section 74110 (c) and (d) an institution shall file its annual report by December 1st of every year. As of May 17, 2018, the Bureau has not received an annual report for the 2015 and 2016 calendar years International Public Safety United(Institution), Institution code 29927731

Pursuant to CEC section 94923(a) The Student Tuition Recovery Fund relieves or mitigates economic loss suffered by a student while enrolled in an institution not exempt from this article pursuant to Article 4 (commencing with section 94874), who, at the time of his or her enrollment, was a California resident or was enrolled in a California residency program, prepaid tuition, and suffered economic loss.

All institutions are required to submit a Student Tuition Recovery Fund (STRF) Assessment Reporting Form to the Bureau no later than the last day of the month following the close of the quarter. The Bureau sends notifications/reminders to all approved institutions prior to close of each quarter. As of May 17, 2018, International Public Safety United, Institution code 29927731 has not submitted the STRF Assessment Reporting Forms for the 4th quarter of 2015, 1st and 4th quarter of 2016 and 1st quarter of 2017.

Waterman Avenue, No. C36, San Bernardino, CA 92408, that the annual fee for calendar year 2017 was due on December 1, 2017. As of May 17, 2018, the Bureau has not received the annual fee from the Institution.
The Institution failed to pay its annual fee for calendar year 2017.
Order of Abatement: The Bureau orders the Institution to submit its annual fee for 2017 in accordance with 5, CCR 74006(a)(b) and CEC 94930.5(d)(1)(A) In addition, the Institution must pay all late payment penalty fees.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference **and/or** Administrative Hearing' form (enclosed) within <u>30 days</u> from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one later.* Unless a written request for an informal conference **and/or** an administrative hearing is signed by you and delivered to the Bureau by **June 16, 2018**, you will be deemed to have waived or forfeited your right to appeal this matter.

EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **May 17, 2018**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **June 16, 2018**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
