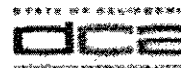

Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager for the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

**CITATION**

A Citation is hereby issued to Magnum Range, Inc., Owner of Magnum Security Academy (Institution) located at 766 South Lugo Ave., San Bernardino, CA 92408, pursuant to Business and Professions Code section 125.9 and 149; California Education Code (CEC) section 94944; and Title 5 of the California Code of Regulations (5 CCR) section 75020 for the violation(s) described below.

**BACKGROUND**

On April 15, 2016, the Bureau received a complaint alleging that the Institution was operating without Bureau approval in violation of CEC section 94886. Bureau staff investigated the complaint and found that the Institution submitted an Application for Verification of Exempt Status to the Bureau on August 12, 2013. On November 21, 2013, the Bureau denied the Institutions Application for Verification of Exempt Status. Bureau staff found evidence showing that the Institution was accepting state and federal student financial aid through California's Department of Rehabilitation (DOR) placing it outside of the qualifications of an exempt institution as outlined in CEC section 94874(f). The Institution does not have an Application for Approval to Operate pending with the Bureau, and it does not meet any of the other qualifications of an exempt institution as outlined by CEC section 94874.

VIOLATION(S)

#	Below you will find the California Education Code (CEC) and/or Title 5 of the California Code of Regulations (5, CCR code) section(s) of law you are charged with violating.
1.	<p><b>Violation:</b> <b>CEC 94886. Approval to Operate Required</b></p> <p><i>"Except as exempted in Article 4 (commencing with Section 94874) or in compliance with the transition provisions in Article 2 (commencing with Section 94802), a person shall not open, conduct, or do business as a private postsecondary educational institution in this state without obtaining an approval to operate under this chapter."</i></p> <p><b>CEC 94817.5. Approved to Operate or Approved</b></p> <p><i>"Approved to operate" or "approved" means that an institution has received authorization pursuant to this chapter to offer to the public and to provide postsecondary educational programs."</i></p> <p><b>CEC 94868. To Offer to the Public</b></p> <p><i>"To offer to the public" means to advertise, publicize, solicit, or recruit."</i></p> <p><b>CEC 94869. To Operate</b></p> <p><i>"To operate" means to establish, keep, or maintain any facility or location in this state where, or from which, or through which, postsecondary educational programs are provided."</i></p> <p>On April 15, 2016, the Bureau received a complaint alleging that Institution was operating without approval in violation of CEC section 94886.</p> <p>On June 7, 2017, Bureau staff found that the Institution submitted an Application for Verification of Exempt Status to the Bureau on August 12, 2013. On November 21, 2013, the Institutions Application for Verification of Exempt Status was denied by the Bureau.</p> <p>On July 25, 2017, Bureau staff interviewed DOR Training Coordinator, LS, who stated that DOR refers students to the Institution. LS also stated that DOR reimburses the Institution for the training it provides to those students.</p> <p>On August 3, 2017, Bureau staff interviewed the Institution's Director of Marketing and Student Admission, C.F. During that interview, C.F. confirmed that DOR refers students to the Institution and that DOR pays the Institution for the training it provides to those students. As such, the Institution does not qualify as an exempt institution per CEC section 94874. Additionally, the Institution does not have an Application for Approval to Operate pending with the Bureau.</p> <p>Therefore, the Bureau has determined that the Institution is operating as an unapproved institution, in violation of CEC 94886.</p>

**Order of Abatement:**

The Bureau Orders that Institution cease operating as a Private Postsecondary Educational Institution. Institution must cease recruiting or enrolling students, cease all instructional services, and advertising those services in any form or media, including its website at [www.davesmagnumrange.com](http://www.davesmagnumrange.com), and any other websites not identified here that are associated with the Institution, until such time as an approval to operate is obtained from the Bureau. The Institution must disconnect all telephone service numbers including but not limited to, (909) 388-1350, that are associated with the Institution until such time as an approval to operate is obtained from the Bureau. To comply with the Order of Abatement the Institution must submit a school closure plan to the Bureau pursuant to California Education Code section 94926. The institution must provide a roster of each student currently enrolled at the Institution. The roster must include the names of the students, their contact information (including phone number, email address, and physical address), the programs in which they are enrolled, the amount paid for the programs.

**Assessment of Fine**

The fine for this violation is \$100,000.00

**TOTAL ADMINISTRATIVE FINE DUE: \$100,000.00**

ASSESSMENT OF A FINE

In accordance with CEC section 94944; and 5, CCR section 75020(b), the Bureau hereby orders this assessment of a fine in the amount of **\$100,000.00** for the violations described above. **Payment must be made, to the Bureau, within 30 days from the date of service of the Citation.**

COMPLIANCE WITH ORDER OF ABATEMENT

In accordance with the provisions of 5, CCR Section 75020 (b) the Bureau hereby issues the order(s) of abatement described above. In accordance with Business and Professions Code Section 149, the Bureau may disconnect any telephone service numbers used by an unapproved Institution. **Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within 30 days from the date of service of the Citation.**

APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation - Request for Informal Conference and/or Administrative Hearing' form (enclosed) within 30 days from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.*

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **October 7, 2018**, you will be deemed to have waived or forfeited your right to appeal this matter.

EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **September 7, 2018**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **October 7, 2018**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.


