22 1. On or about August 27, 2012, the Bureau for Private Postsecondary Education
23 ("Bureau") received an application for Renewal of Approval to Operate an Institution Non-
24 Accredited (application number 25301) from Fellowship Bible Institute and College of Theology
25 and Urban Studies ("Respondent"). On February 1, 2016, the Bureau issued a deficiency letter by
26 mail and by email, explaining the deficiencies in Respondent's application. On March 7, 2016,
27 the Bureau emailed the deficiency letter to Respondent again. On March 24, 2016, the Bureau e-

1 mailed the deficiency letter to Respondent again. On or about June 16, 2016, the Bureau issued
2 Respondent a Notice of Denial of Application for Renewal of Approval to Operate. On or about
3 August 7, 2016, Respondent sent the Bureau a letter requesting an administrative hearing.


4 2. On or about July 7, 2017, Joanne Wenzel, former Chief of the Bureau for Private
5 Postsecondary Education, solely in her official capacity, filed Statement of Issues No. 1002098.

6 3. The Bureau hereby withdraws Statement of Issues No. 1002098. The basis for this
7 withdrawal is that, on or about August 29, 2017, counsel for the Bureau received Respondent's
8 Notice of Withdrawal of Request for Hearing.

9 4. WHEREFORE, IN THE INTEREST OF JUSTICE, Statement of Issues No. 1002098
10 is hereby withdrawn without prejudice.
