


<p>§71920 – Student Records.</p>	<p>(b) In addition to the requirements of section 94900, the file shall contain all of the following pertinent student records:</p> <p>(1) Written records and transcripts of any formal education or training, testing, or experience that are relevant to the student's qualifications for admission to the institution or the institution's award of credit or acceptance of transfer credits including the following:</p> <p>(A) Verification of high school completion or equivalency or other documentation establishing the student's ability to do college level work, such as successful completion of an ability-to-benefit test;</p> <p>The institution failed to include the required policies in the brochure.</p> <p><i>The institution must submit revised brochure to show the "Admissions Requirements" section providing the institution's verification of high school completion or equivalency or other documentation required for admission. In addition, including the ability-to-benefit test information with the the name of the ability-to-benefit test accepted and the passing score.</i></p>
<p>§76130 – Collection and Submission of Assessments.</p>	<p>(c) The STRF Assessment Reporting Form shall contain the following information:</p> <p>(1) Total number of students who signed enrollment agreements for educational programs during the reporting period; and</p> <p>(2) Total number of students eligible for STRF who signed enrollment agreements for educational programs during the reporting period; and</p> <p>The institution failed to submit the requested information.</p> <p><i>Institution must submit records to substantiate the data reported for the 2nd and 3rd Quarter 2015 STRF Assessment Reporting forms.</i></p>
