Each of these items in the Student Performance Fact Sheet shall include a line for the student to initial and shall be initialed and dated by the student.</p> <p>Student files are not complete and do not include all the required documentation to deem an enrollment agreement valid. Student files do not contain an initialed and signed SPFS for the program enrolled.</p>
CEC §94909 - Ability-to-Benefit- Students.	<p>(a) Before an ability-to-benefit student may execute an enrollment agreement, the institution shall have the student take an <i>independently administered examination</i> from the list of examinations prescribed as of July 1, 2012, by the United States Department of Education pursuant to Section 484(d) of the federal Higher Education Act of 1965 (20 U.S.C. Sec. 1070a et seq.). <i>The student shall not enroll unless the student achieves a score, as specified by the United States Department of Education, demonstrating that the student may benefit from the education and training being offered.</i></p> <p>(b) If the United States Department of Education does not have a list of relevant examinations that pertain to the intended occupational training, the bureau may publish its own list of acceptable examinations and required passing scores.</p> <p>The CASAS test is not an approved test for Ability-to-Benefit. CEC §94909 – Minimum Requirements for School Catalog.	<p>(a) Except as provided in subdivision (d), prior to enrollment, an institution shall provide a prospective student, either in writing or electronically, with a school catalog containing, at a minimum, all of the following:</p> <p>(9) The schedule of total charges for a period of attendance and an estimated schedule of total charges for the entire educational program.</p> <p>The catalog does not include both the total charges for the period of attendance AND estimated schedule of total charges for the entire program.</p>

If an instructor does not possess the required three years of experience, education and training in the subject area they are teaching, the institution shall document the qualifications the instructor possesses that are equivalent to the minimum</p>

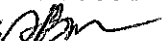

The institution reported a total of 174 programs were offered in 2013. This number should reflect the number of "programs" offered not the number of diplomas/certificates awarded. Additionally, the institution failed to report the ESL program. This should reflect zero if no enrollments for the period.</p>
<p>CCR §76140 – Record-Keeping Requirements.</p>	<p>(a) A qualifying institution shall collect and maintain records of student information to substantiate the data reported on the STRF Assessment Reporting Form and records of the students' eligibility under the Fund.
