1	5 CCR § 71800 (c)	<p>Violation Description: The institution’s enrollment agreement for the Barbering (1500 Hours) and Cosmetology (1600 Hours) programs, failed to identify program start date and scheduled completion date.</p> <p>Correction: The institution shall update the enrollment agreement to identify the period covered by the enrollment agreement, pursuant to 5 CCR § 71800 (c).</p>
2	5 CCR § 71800 (b)	<p>Violation Description: The institution’s enrollment agreement for the Barbering (1000 Hours), Cosmetology (1000 Hours), Esthetics, and Nail Care programs, failed to identify the period covered by the enrollment agreement.</p> <p>Correction: The institution shall update the enrollment agreement to identify the period covered by the enrollment agreement, pursuant to 5 CCR § 71800 (b).</p>

Violation	Code Section Violated	Description of the violation and required correction.
3	CEC § 94911 (e)(2) conjunction with 5 CCR § 71750 (c)(1)	<p>Violation Description: The pro-rata refund sample in the institution's enrollment agreements do not comply with 5 CCR § 71750 (c)(1).</p> <p>Correction: The institution shall update the pro-rata refund policy in the enrollment agreements pursuant to CEC § 94911(e)(2) and 5 CCR § 71750 (c)(1).</p>
4	CEC § 94897 (o)	<p>Violation Description: The "Request Enrollment Information" section on the institution's website, contains a prohibitive business practice regarding requiring a prospective student to provide personal contact information in order to obtain, from the institution's internet website, educational program information that is required to be contained in the school catalog.</p> <p>Correction: The institution shall update its website, to remove the above-mentioned requirement pursuant to CEC § 94897 (o).</p>


Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

(1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or

(2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
