1	CEC § 94919(d)	<b>Violation Description:</b> The institution's catalog, page 10 contains the following unenforceable statement: "Supplies (kits) received and accepted by the student are non-refundable." This statement violates CEC § 94919(b) which identifies a deposit or application fee, not to exceed \$250 to be the only non-refundable fee during the cancellation period.  <b>Correction:</b> The institution shall update its catalog to comply with CEC § 94919(d).
2	5 CCR § 71810(b)(3)	<b>Violation Description:</b> The institution's catalog fails to specify whether visa services are provided or whether the institution will vouch for student status and any associated charges.  <b>Correction:</b> The institution shall update its catalog to include whether it provides visa services or whether it will vouch for student status and any associated charges, pursuant to 5 CCR § 71810(b)(3).
3	CEC § 94909(a)(9)	<b>Violation Description:</b> The institution's catalog fails to contain the schedule of total charges for a period of

		attendance and an estimated schedule of total charges for the entire educational program.  <b>Correction:</b> The institution shall update its catalog to provide a schedule of total charges for a period of attendance and an estimated schedule of total charges or the entire educational program, pursuant to CEC § 94909(a)(9).
4	CEC § 94909(a)(10)	<b>Violation Description:</b> The institution's catalog fails to contain a statement reporting whether it participates in state financial aid.  <b>Correction:</b> The institution shall update its catalog to provide a statement reporting whether it participates in state financial aid, pursuant to CEC § 94909(a)(10).
5	CEC § 94909(a)(3)(D)	<b>Violation Description:</b> The institution's catalog fails to contain the required OSAR statement:  <i>"The Office of Student Assistance and Relief is available to support prospective students, current students, or past students of private postsecondary educational institutions in making informed decisions, understanding their rights, and navigating available services and relief options. The office may be reached by calling (888) 370-7589, option #5 or by visiting <a href="http://osar.bppe.ca.gov">osar.bppe.ca.gov</a>."</i>  <b>Correction:</b> The institution shall update the catalog to include the required OSAR statement pursuant to CEC § 94909(a)(3)(D).
6	5 CCR § 71730(b)	<b>Violation Description:</b> The institution failed to maintain in writing a statement of duties, responsibilities, and performance evaluation criteria for the Chief Academic Officer.  <b>Correction:</b> The institution shall produce a statement of duties, responsibilities and performance evaluation criteria for the Chief Academic Officer, pursuant to 5 CCR § 71730(b).


Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of

disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

**Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.**

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
