1	5 CCR § 71720 (b)(2)	Violation Description: Institution fails to include in faculty number 2, Nisma Ibrahim's file, documentation of continuing education.	
		Correction: Include in faculty number 2, Nisma Ibrahim's file, documentation of continue education. Provide a copy of the documentation of continuing education that shows compliance with 5 CCR § 71720 (b)(2).	
2	CEC § 94909 (a)(5)	Violation Description: Institution states on page 20 of the catalog that the Versatile Medical Assistant program does not require externship which contradicts page 23 statements where 60 hours of externship is included as a module.	
		Correction: Change the statement on page 20 of the catalog to reflect the 60 hours of externship required in the Versatile Medical Assistant program. Provide a copy of the catalog that shows compliance with CEC § 94909 (a)(5).	

Violation	Code Section Violated	Description of the violation and required correction.
3	5 CCR § 71735 (a)	Violation Description: Institution did not have necessary equipment to support the achievement of the educational objectives of all of the courses.
		Correction: Provide a list of equipment and supplies maintained at the institution to support the achievement of the educational objectives that shows compliance with 5 CCR § 71735 (a).

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

(1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or

(2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
