Elizabeth Elias issues this citation in her official capacity as Bureau Chief at the Bureau for Private Postsecondary Education, California Department of Consumer Affairs (hereinafter referred to as the "Bureau").

LICENSING HISTORY

- On or about October 15, 2024, the Bureau renewed an Approval to Operate a Private Postsecondary Institution, Institution Code 3303961, to RTC College (formerly known as Riverside Training Center), hereinafter referred to as the "Institution." This Approval to Operate will expire on or about October 15, 2029, unless renewed.

DISCIPLINE HISTORY

CITATION JURISDICTION

- This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

CAUSE FOR CITATION & ASSESSMENT OF FINE AND/OR ORDER OF ABATEMENT

- The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

CEC section 94900(b) – Required Student Records and 5 CCR section 71920(b)(5) – Student Records and 5 CCR section 71930(e) – Maintenance of Records

Cause for Citation: On or about July 6, 2026, the Bureau completed an investigation based on a complaint filed against the Institution. Through the course of the investigation, Bureau staff found that nine student files reviewed failed to maintain transcripts within the file, which is a required institutional record pursuant to CEC section 94900(b).

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class B” violation. The Institution is issued a fine of \$1,001.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to ensure all student records are maintained pursuant to CEC section 94900 and 5 CCR sections 71920 and 71930. The Institution must submit a statement of attestation confirming that it has corrected the violation and will ensure that all student records contain copies of degrees or certificates granted, including the dates awarded. The statement of attestation must be dated and signed by an authorized representative of the Institution.

Violation #2:

5 CCR section 71920(b)(1)(A) – Student Records, 5 CCR section 71930(e) – Maintenance of Records and CEC section 94897(u) – Prohibited Business Practices

Cause for Citation: On or about July 6, 2026, the Bureau completed an investigation based on a complaint filed against the Institution. Through the course of the investigation, Bureau staff found two student files failed to contain a verification of high school diploma or its equivalent establishing the student’s ability to do college level work. Further, Bureau staff determined that the Institution failed to adhere to its own admissions policy requiring proof of

either a high school diploma or its equivalent to demonstrate the student's qualifications for admission.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a statement of attestation confirming that it has corrected the violation and will ensure that the Institution adheres to its stated policies pursuant to CEC section 94897(u) and that it will maintain required student records pursuant to 5 CCR sections 71920 and 71930. The statement of attestation must be dated and signed by an authorized representative of the Institution.

COMPLIANCE WITH ORDER OF ABATEMENT

5. In accordance with the provisions of CEC section 94936 and 5 CCR section 75020, the Bureau issues the order(s) of abatement described above. Evidence of compliance with the order of abatement must be submitted to the Bureau within 30 days from the date of issuance of this citation. 7. You have the right to contest this citation through an informal conference with the Bureau pursuant to 5 CCR section 75020 and/or through an administrative hearing in accordance with Chapter 5 (Commencing with section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this citation, the Bureau must receive a written request within 30 days from the date of issuance of this citation asking for an informal conference and/or administrative hearing or you may also submit the enclosed *Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing* form.

Pursuant to 5 CCR section 75050, failure to comply with this citation order, its order of abatement, and/or administrative fine by the required due date is grounds for denial or discipline of an approval to operate. Where a citation is not contested and fine is not paid, the full amount of the assessed fine shall be added to the fee for renewal of the approval to operate. An approval to operate shall not be renewed without payment of the renewal fee and fine.
