Beth Scott issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Enforcement Chief of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

#### **CITATION**

A Citation is hereby issued to Tracy Hua, Owner of Sebastopol Massage Center (Institution) located at 23615 El Toro Rd. Ste. 1 Lake Forest, CA 92630 pursuant to Business and Professions Code section 125.9; California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

## **BACKGROUND**

On May 26, 2018, an unannounced compliance inspection took place at the Institution pursuant to CEC section 94932.5. As a result of four minor violations that were unable to be cleared before the end of the inspection, the Institution was issued Notice to Comply (NTC) #CA 4900941 0518 (Attachment A). The Institution was given thirty days from the date of the inspection to either remedy all violations listed in the NTC or submit a written Notice of Disagreement. A Notice of Disagreement was not received, and the Institution was not able to clear any of the four violations within thirty days.

#### VIOLATION

# Below you will find the California Education Code (CEC) and/or Title 5 of the California Code of Regulations (5, CCR code) section(s) of law you are charged with violating.

#### 1. Violation:

### CEC Section 94935(a)(b)(c)(h) - Notice to Comply

(a) Bureau staff who, during an inspection of an institution, detect a violation of this chapter, or regulations adopted pursuant to this chapter, that is a minor violation as determined by the bureau, pursuant to regulations adopted by January 1, 2011, shall issue a notice to comply before leaving

the institution. The bureau shall establish a voluntary informal appeal process, by regulation, within one year of the enactment of this chapter.

- (b) An institution that receives a notice to comply shall have no more than 30 days from the date of inspection to remedy the noncompliance.
- (c) Upon achieving compliance, the institution shall sign and return the notice to comply to the bureau.
- (h) If an institution fails to comply with a notice to comply within the prescribed time, the bureau shall take appropriate administrative enforcement action.

The Institution failed to submit documentation to clear the outstanding violations and did not submit a Notice of Disagreement by June 16, 2018.

#### Order of Abatement:

The Institution shall submit to the Bureau sufficient evidence to clear each of the four outstanding violations on the Notice to Comply.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing' form (enclosed) within <u>30 days</u> from the date of service of the Citation. If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by February 23, 2019, you will be deemed to have waived or forfeited your right to appeal this matter.

#### EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on January 24, 2019. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **February 23, 2019**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
