# APPEAL OF CITATION INFORMAL CONFERENCE DECISION: CITATION AFFIRMED

On August 26, 2019, an informal telephone conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No. 1819187 (Citation) against Welding Skills and Training Center, Inc., Owner of Welding Skills and Training Center, Inc. (Institution). In attendance were Marina O'Connor, Licensing Chief, Randy McClure, Owner and Aric M. Davison, Attorney.

Pursuant to Business and Professions Code, section148; California Education Code (CEC), section 94944; and Title 5 of California Code of Regulations (5, CCR), section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 1819187.

It is the decision of the Licensing Chief that on November 6, 2019, Citation No. 1819187 is <u>affirmed</u> for the following reason(s):

## CEC Section 94868. To Offer to the Public

"To offer to the public" means to advertise, publicize, solicit, or recruit."

#### **CEC Section 94869. To Operate**

"To operate" means to establish, keep, or maintain any facility or location in this state where, or from which, or through which, postsecondary educational programs are provided."

On January 8, 2019, Bureau staff found that the Institution was operating a private postsecondary educational institution and offering educational programs.

The Institution maintains an active website (<u>https://www.weldingclass.org/</u>) and advertises a collection of welding related educational programs ranging from \$35.00 for hourly sessions to \$7,495 for bundle packaged programs. The Institution issues welding certifications, offers basic classes, and offers assistance to those needing help obtaining a job.

On October 18, 2016, the Bureau denied the Institution's application for a Verification of Exemption under CEC section 94874(d)(2). The Institution was notified via mail. The letter stated in part that "a person shall not open, conduct, or do business as a private postsecondary educational institution in this state without obtaining an approval to operate under this chapter."

### Order of Abatement:

The Bureau orders that the Institution cease to operate as a private postsecondary educational institution, unless the Institution qualifies for an exemption under CEC section 94874. The Institution must discontinue recruiting or enrolling students and cease all instructional services and advertising in any form or type of media, including <a href="https://www.weldingclass.org">https://www.weldingclass.org</a> and any other websites not identified here that are associated with the Institution, until such time as an approval to operate is obtained from the Bureau. The Institution must disconnect all telephone service numbers including but not limited to (909) 476-4149, that are associated with Institution until such time as an approval to operate is obtained from the Bureau. To comply with the Order of Abatement the Institution must submit a school closure plan to the Bureau pursuant to California Education Code section 94926. The Institution must provide a roster of each student currently enrolled at the Institution. The roster must include the names of the students, their contact information (including phone number, email address, and physical address), the programs in which they are enrolled, the amount paid for the programs.

## Assessment of Fine

The fine for this violation is <u>\$5,000.00</u>

## ORDER OF ABATEMENT

The Bureau orders that you comply with the orders described in the 'Violation Code Sections' of this document and submit evidence of compliance within <u>30 days</u> from the date of this decision.

#### APPEAL OF CITATION

You *do not* have the right to request another Informal Conference to appeal this affirmed Citation. You *do*, however, have the right to appeal this affirmed Citation through an Administrative Hearing. A hearing before an Administrative Law Judge will be scheduled and you will be notified of the hearing date. The hearing will be held pursuant to Chapter 5 (commencing with section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

#### EFFECTIVE DATE OF CITATION AND FINE ASSESSMENT

This affirmed Citation is effective on November 19, 2019. The order of abatement and payment are due by **December 19, 2019**.

Failure to abate the violation or to pay the administrative fine within the time allowed is grounds for denial of an application for an approval to operate or discipline. The Bureau will promptly take all appropriate action to enforce the Affirmed Citation and recover the civil penalties prescribed therein or found to be due after a hearing.
