#### **ACICS** Accredited Institution

As you are probably aware, the United States Department of Education (Department) has decided to deny re-recognition to the Accrediting Council for Independent Colleges and Schools (ACICS). You are probably also aware that ACICS does have the option to appeal the decision to the Secretary of Education (Secretary). On September 22, 2016, ACICS issued the following statement: "ACICS plans to appeal the SDO's decision to Secretary King. While the appeal is pending, ACICS retains its federal recognition and remains determined to fully execute its accreditation responsibilities in a professional manner." If ACICS appeals the decision, the loss of recognition will indeed be stayed and ACICS will retain its federal recognition during the appeal, and there is no set timeframe for when a decision on the appeal must be made by the Secretary.

## What does this mean for your school's approval to operate in California?

The Bureau's records indicate that your institution is Approved By Means of Accreditation (ABMA), with your accreditor listed as ACICS. This means that your ABMA is dependent on ACICS's continued ability to accredit your school as an accrediting agency recognized by the United States Department of Education. <u>See</u>, the California Private Postsecondary Education Act of 2009 (Act), Education Code sections 94890, 94813, and 94814.

Accordingly, ACICS's loss of recognition by the Department will remove the basis for the institution's accreditation status, and the Bureau may have to initiate proceedings to revoke your school's ABMA.

However, the Bureau will currently accept applications for "full approval" from your institution or alternatively, applications for ABMA with a new accreditor. If your school has no degree granting programs, you may apply for full approval; even if your school has degree granting

programs, you may still apply for full approval, but ultimately will have to comply with the requirement for institutional accreditation. The Bureau cannot guarantee that the applications will be granted or processed prior to the potential loss of ACISC's recognition by the Department. The Bureau does not waive its right to move for emergency relief to restrict enrollment or for other relief pursuant to the Act and regulations.

# What information does the Bureau require from you?

As we stated previously, this is an unprecedented situation, and the Bureau continues to analyze the issues necessary to address the situation and to do all it can to protect students from potential harm. As part of the process, and because the Bureau has a mandate to protect students and ensure minimum operating standards at your institution, it requires the following information from you.
