School Hours

Language Pacifica is open weekdays from 8:30 a.m. to 5:00 p.m. year-round except on holidays, which include one or two weeks at the end of the year. Our sessions last eight weeks, and two 8-week sessions make each level. There are six levels. All classes are five days per week, Monday through Friday.

Admission Criteria

- Full-time students must be at least 16 years old.
- All students must place between Level 1 and Level 6 on our placement test. Our placement test is accepted as an alternate ability-to-benefit test (ATB) for those without a high school diploma or equivalent.

Admission Procedure

Language Pacifica admits new students every Monday. The enrollment form is due on admission. The placement test and orientation begin at 8:30 a.m. on the first day of classes. Classes are joined at 11:00 a.m. Payment of tuition, fees and textbooks is due before the end of the day. Full-time students should begin on session beginning dates.

Level Placement

Your class level will be based on the results of your placement test, which consists of speaking, writing, listening, and grammar. **Note:** If the level of your class seems too high or low for you, please speak with the director about the possibility of changing it. Please don't write in your textbooks until you are sure that the level is suitable for you.

College Connections

Language Pacifica has partnerships with local colleges and a university, including Foothill College (www.foothill.edu), De Anza College (www.deanza.edu), Cañada College (www.canadacollege.edu), College of San Mateo (www.collegeofsanmateo.edu), Skyline College (www.skylinecollege.edu) and Notre Dame de Namur University (www.ndnu.edu), in which completion of our Level 5 is accepted as proof of English proficiency for undergraduate admissions and completion of Level 6 is accepted by NDNU for graduate school admissions. In addition, Language Pacifica has partnerships with 12 other colleges and universities around the country, which allow conditional admission to students in Levels 5 and 6 with a test given at Language Pacifica. Please talk with our director for more information.

Student Visa Applicants Full-time students are eligible for the I-20 for the requested study period to apply for the F-1 visa. For the I-20, the completed enrollment form is necessary, along with : 1) A copy of your passport page (and passport copies of your dependents, if you'll bring dependents); 2) A copy of the bank letter dated within 6 months that will be shown to the embassy showing at least \$2500/ month available for the months on the I-20 plus \$1250/month per dependent for "dependent care expenses"; 3) Language Pacifica's application fee of \$95. When we have received these, we'll make the I-20 and send it. Ask the school for shipping costs.

▶ If you'll transfer your I-20 from another US school, please attach a copy of your current I-20. We will send a transfer notice to your current school, then you will receive your new I-20 when you begin here. Let us know if you need it earlier.

▶ Next, please complete the Form I-go1 at http://www.ice.gov/sevis/igo1 and submit it, with its \$200 fee, to the U.S. government. Print the receipt. You will need to take the original paper receipt to your visa interview.

Course and Level Information

We use the Common European Framework of Reference for Languages (CEFR) as a basis for our learning outcomes. Level 1

The goal of Level 1 is to begin the process of developing students' ability to express themselves in academic, work, or social environments in which the primary language used is English.

Learning Outcomes

Speaking: Can interact in a simple way but communication is totally dependent on repetition at a slower rate of speech, rephrasing and repair. Can ask and answer simple questions, initiate and respond to simple statements in areas of immediate need or on very familiar topics.

Reading: Can understand very short, simple texts a single phrase at a time, picking up familiar names, words and basic phrases and rereading as required.

Writing: Can write simple isolated phrases and sentences.

Grammar: Shows only limited control of a few simple grammatical structures and sentence patterns in a learnt repertoire.

Course Objectives

Speaking: Very simple topics such as introductions, directions, likes and dislikes; short, clear, slowly stated simple questions and responses

Reading: Students work with Level 1 textbook, which uses about 300 key words.

Writing: Students are taught how to write sentences.

Grammar: Introduction to verbs "be" and "have", simple present, present progressive, nouns as subjects and objects, introduction to past tense

Course Materials

Reading/Writing: Foundations, Molinsky/Bliss

Grammar: Basic English Grammar A, Azar/Hagen

Level 2

The goal of Level 2 is to continue developing students' ability to express themselves in academic, work, or social environments in which the primary language used is English.

Learning Outcomes

Speaking: Can interact with reasonable ease in structured situations and short conversations, provided the other person helps if necessary. Can manage simple, routine exchanges without undue effort; can ask and answer questions and exchange ideas and information on familiar topics in predictable everyday situations. Can communicate in simple and routine tasks requiring a simple and direct exchange of information on familiar and routine matters to do with work and free time. Can handle very short social exchanges but is rarely able to understand enough to keep conversation going of his/her own accord.

Reading: Can understand short, simple texts on familiar matters of a concrete type which consist of high frequency everyday or job-related language. Can understand short, simple texts containing the highest frequency vocabulary, including a proportion of shared international vocabulary items.

Writing: Can write a series of simple phrases and sentences linked with simple connectors like "and," "but" and "because." Grammar: Uses some simple structures correctly, but still systematically makes basic mistakes – for example tends to mix up tenses and forgets to mark agreement; nevertheless, it is usually clear what he/she is trying to say.

Course Objectives

Speaking: Students focus on understanding and communicating main ideas and getting the main idea of what others saying. Short conversations are held on basic topics, including but not limited to daily activities, subjects of personal interest, and plans for future activities.

Reading: Students become familiar with texts (from textbook and outside readings) that use about 600 key words.

Writing: Students are taught to write a group of complete sentences about a topic and a narrative using past tense. Writing is used for strengthening fluency, practicing structures, and increasing vocabulary.

Grammar: Introduction to the present tense, past tense, future tense, modals, nouns and modifiers, possessives, comparisons, and irregular verbs

Course Materials

Reading/Writing: American Headway 1, Soares Grammar: Basic English Grammar B, Azar/Hagen

Level 3

The goal of Level 3 is to improve students' ability to express themselves clearly and fully in academic, work, or social environments in which the primary language used is English.

Learning Outcomes

Speaking: Can communicate with some confidence on familiar routine and non-routine matters related to his/her interests and professional field. Can exchange, check and confirm information, deal with less routine situations and explain why something is a problem. Can express thoughts on more abstract, cultural topics such as films, books, music etc. Can exploit a wide range of simple language to deal with most situations likely to arise whilst traveling. Can enter unprepared into conversation on familiar topics, express personal opinions and exchange information on topics that are familiar, of personal interest or pertinent to everyday life (e.g. family, hobbies, work, travel and current events).

Reading: Can read straightforward factual texts on subjects related to his/her field and interest with a satisfactory level of comprehension.

Writing: Can write straightforward connected texts on a range of familiar subjects within his/her field of interest, by linking a series of shorter discrete elements into a linear sequence.

Grammar: Communicates with reasonable accuracy in familiar contexts; generally good control though with noticeable mother tongue influence. Errors occur, but it is clear what he/she is trying to express. Uses, reasonably accurately, a repertoire of frequently used "routines" and patterns associated with more predictable situations.

Course Objectives

Speaking: The emphasis is on personal expression and understanding others. The student will converse on familiar topics such as school, work issues, popular current events, shopping or restaurants.

Reading: The textbook and additional reading materials use about 1000 key words.

Writing: Students in Level 3 begin to work with the structure of the paragraph.

Grammar: Students focus on written and oral use of the present tense, the past tense, the future tense, present perfect, past perfect, questions, nouns and pronouns, and modals.

Reading/Writing: For Your Information 3, Blanchard/Root

Grammar: Fundamentals of English Grammar, Volume A, Azar/Hagen

Level 4

The goal of Level 4 is to enhance students' ability to express themselves clearly and fully in academic, work, or social environments in which the primary language used is English.

Learning Outcomes

Speaking: Can use the language fluently, accurately and effectively on a wide range of general, academic, vocational or leisure topics, marking clearly the relationships between ideas. Can communicate spontaneously with good grammatical control without much sign of having to restrict what he/she wants to say, adopting a level of formality appropriate to the circumstances. Can interact with a degree of fluency and spontaneity that makes regular interaction and sustained relationships with native speakers quite possible without imposing strain on either party. Can highlight the personal significance of events and experiences, account for and sustain views clearly by providing relevant explanations and arguments.

Reading: Can read with a large degree of independence, adapting style and speed of reading to different texts and purposes, and using appropriate reference sources selectively. Has a broad active reading vocabulary, but may experience some difficulty with low frequency idioms.

Writing: Can write clear, detailed texts on a variety of subjects related to his/her field of interest, synthesizing and evaluating information and arguments from a number of sources.

Grammar: Shows a relatively high degree of grammatical control. Does not make mistakes which lead to misunderstanding. <u>Course Objectives</u>

Speaking: The emphasis in Level 4 is on expressing oneself clearly and fully.

Reading: The textbook and other reading materials use about 1400 key words.

Writing: Students begin to write essays. Writing is used for strengthening fluency, practicing structures, and increasing vocabulary.

Grammar: Students work with connecting ideas, comparisons, passive, nouns and articles, adjective clauses, gerunds and infinitives, noun clauses, and phrasal verbs

Course Materials

Reading/Writing: World of Reading 3, Baker-González/Blau Grammar: Fundamentals of English Grammar, Volume B, Azar/Hagen

Level 5

The goal of Level 5 is for students to move towards mastery of expression in academic, work, or social environments in which the primary language used is English.

Learning Outcomes

Speaking: Can express him/herself fluently and spontaneously, almost effortlessly. Has a good command of a broad lexical repertoire allowing gaps to be readily overcome with circumlocutions. There is little obvious searching for expressions or avoidance strategies; only a conceptually difficult subject can hinder a natural, smooth flow of language.

Reading: Can understand in detail lengthy, complex texts, whether or not they relate to his/her own area of specialty, provided he/she can reread difficult sections.

Writing: Can write clear, well-structured texts of complex subjects, underlining the relevant salient issues, expanding and supporting points of view at some length with subsidiary points, reasons and relevant examples, and rounding off with an appropriate conclusion.

Grammar: Consistently maintains a high degree of grammatical accuracy; errors are rare and difficult to spot.

Course Objectives

Speaking: The emphasis in Level 5 is on speaking clearly and correctly. The student aims to converse easily on unfamiliar topics such as current events and academic subjects.

Reading: The textbook and other reading materials use about 1800 key words, and some authentic materials are used at this level. **Writing:** Writing is used for strengthening fluency, practicing structures, and increasing vocabulary; students also work with the essay format.

Grammar: The student works to show competence in the present and past simple and progressive tenses, the perfect and progressive tenses, the future tense, adverb clauses, subject-verb agreement, nouns, pronouns, modals, and the passive.

Course Materials

Reading/Writing: A World of Fiction 1, Marcus

Grammar: Understanding and Using English Grammar, Volume A, Azar/Hagen

Level 6: The goal of Level 6 is for students to achieve mastery of expression in academic, work, or social environments in which the primary language used is English.

Learning Outcomes

Speaking: Has a good command of idiomatic expressions and colloquialisms with awareness of connotative levels of meaning. Can convey finer shades of meaning precisely by using, with reasonable accuracy, a wide range of modification devices. Can backtrack and restructure around a difficulty so smoothly the interlocutor is hardly aware of it.

Reading: Can understand and interpret critically virtually all forms of the written language including abstract, structurally complex, or highly colloquial literary and non-literary writings. Can understand a wide range of long and complex texts, appreciating subtle distinctions of style and implicit as well as explicit meaning.

Writing: Can write clear, smoothly flowing, complex texts in an appropriate and effective style and a logical structure which helps the reader to find significant points.

Grammar: Maintains consistent grammatical control of complex language, even while attention is otherwise engaged (e.g. in forward planning, in monitoring others' reactions).

Course Objectives

Speaking: The student works toward mastery of spoken English with fluent, sophisticated clarity of expression. The emphasis in Level 6 is on correct, articulate expression.

Reading: Texts use about 2200 key words, and many authentic materials are used at this level.

Writing: In addition to writing for strengthening fluency, practicing structures, and increasing vocabulary, students in Level 6 write essays and reports.

Grammar: The student works to show competence in English grammar, including mastery of topics from the text such as noun clauses, adjective clauses, gerunds and infinitives, coordinating conjunctions, adverb clauses, adverbial phrases, conditional sentences and wishes, connectives expressing cause and effect, contrast, and the conditional.

Grammar: Understanding and Using English Grammar, Volume B, Azar/Hagen

Total Number of Hours to Complete Program

The total number of hours to complete the program depends on the course taken, the initial level of English, and the desired level of English to be attained. A student taking Full-time Intensive English, placing into Level 1, and wanting to complete Level 6 would take 2000 hours.

Faculty

Our instructors are chosen for their knowledge of the subject matter and their teaching ability. All have at least Bachelor's degrees and native or native-like fluency in English, plus one or more of the following: Master's or PhD in TESOL, English, Linguistics or a related field; a TESOL certificate or another ESL teaching certificate; a teaching credential in English or a related field; or a combination of education and experience in teaching ESL. Language Pacifica does not discriminate on the basis of gender, age, race, religion, or sexual orientation.

Academic Progress

We want you to make a lot of progress here! Please read the following for information about our policies.

Grading

You will receive grades on assignments, quizzes and tests, and your spoken English during your course. These should help you to know how you are doing and motivate you to succeed. In addition, students who complete a session will receive a final grade for that session.

Integrated Skills final grade components are: Speaking = 40%, Graded Assignments = 20%, Quizzes = 20%, Midterm = 10%, Final = 10%

Grammar final grade components are: Applied Grammar (your use of the learned grammar) = 40 %, Quizzes and tests = 20 %, Midterm = 20%, Final = 20 %

Grades: A+ =98-100%, A=93-97%, A- = 90-92%, B+ =88-89%, B= 83-87%, B- =80-82%, C+ =78-79%, C=73-77%, C- =70-72%, D+ =68-69%, D= 63-67%, D- =60-62%, Fail=59% and under

Promotion

Each level is composed of two 8-week sessions. A grade of "C" or better for both sessions is needed for promotion to the next level. Students who arrive in the middle of a session may speak with the instructor and the director about making up the work that was missed in order to complete the session. A student who takes just part of one session but completes the next session could also be promoted if the instructor and director feel that s/he has completed the learning outcomes of the level.

Attendance

Although you will not be graded on attendance, attendance is important for learning new material and practicing your skills. Students who do not attend classes regularly do not, as a rule, make satisfactory academic progress. In addition, F-1 students must maintain at least 80% attendance as part of the visa requirement. Acceptable attendance includes all class period each class daily.

Leave of Absence

If you plan to be absent from school for a week or a number of weeks, please complete a "Vacation Request Form" in the office and you will not pay tuition for that time.

Staying in Status as an F-1 Student

The student visa makes you a legal visitor to the US only when you are "in status". To stay in status, you must be a full-time student at the school that issued you the I-20. If you finish the time period on your I-20 and want to keep your student status, you must have your I-20 extended or transferred.

The following are necessary for staying in status at Language Pacifica:

- Come to Language Pacifica to register and begin classes by the beginning date on your I-20. You may arrive in the US no more than 30 days before this date.
 - If you can't arrive in the US on time, contact the school director to request a new I-20 with a later beginning date. You'll use this new I-20 when you enter the US.
 - If you arrive in the US by the beginning date on your I-20 but do not register or begin classes, the school must cancel or terminate your I-20 and you will be out of status (an illegal visitor).
- Maintain at least 80% attendance in your full-time course of study.
 - Consult with the director before dropping below a full course of study for any reason.
 - If you are sick, call the school at (650) 321-1840 for an excused absence. A doctor's note is required when there is an extended period of illness.
- o Maintain normal and satisfactory progress in our program. (See "Academic Progress", p. 7.)
- Talk with the director to extend your program of study at least one week before the end date on your I-20.
- Do not work in the US.

In addition, you must notify the director if:

- Your address changes (within 10 days of the change)
- There is any change in your sources of financial support
- You will travel outside the United States
- You apply for or receive a change of nonimmigrant status (visa type)
- You want to transfer to another school
- There is any change in the status of your dependents

Academic Probation and Dismissal

If your attendance is below 80% for a session or if you do not make an effort to maintain normal and satisfactory progress in our program, you will receive a warning notice. If the problem continues, you will be placed on academic probation. Academic probation signals your last chance to be a full-time student. If the problem isn't solved, you will be expelled from the school. You may need to request F-1 reinstatement from the US government to continue as a student in the United States. If you are in a school homestay, you will need to move out immediately. If you are expelled from the school, there will be no tuition refund.

Retention of Student Records

Language Pacifica retains physical student records for at least five years. Transcripts are kept indefinitely.

Housing Options

Language Pacifica has no responsibility to find or assist a student in finding housing. Housing costs in this area range from about \$1000/month to \$5000/month.

Homestay

Most Language Pacifica students who require housing stay with a host family. We select our hosts carefully in a process which includes an interview and a meeting at the home. Most of our hosts have been working with us for many years. Our homestays are located in the area between San Bruno to the north and Mountain

View to the south and are accessible by about an hour or less of public transportation (including walking to/from the bus or train stop and waiting for transfers.)

You may choose homestay with breakfast and dinner (with or without weekend lunches) or homestay with no meals (which includes use of the kitchen.)

Students who are uncomfortable with hosts for any reason may talk with the director; communication can solve issues before they become problems. It is possible to change hosts with two weeks' notice.

Advantages to staying with a host include the increased amount of practice with the

English language and understanding of the American lifestyle it offers. Many students make lifelong friendships with their hosts. Language Pacifica defines "host family" as a single woman, a single woman with children, or a couple with or without children.

Other Housing Options

Public Transportation

- The **Clipper Card** is a card that can hold Caltrain passes, bus passes, and cash value. You can buy it at some local stores such as Walgreen's or Whole Foods. It can also be ordered online. Go to <u>www.clippercard.com</u> for more information. Ask school personnel if you have questions about how to buy or use a Clipper Card.
- The Caltrain monthly pass for any two zones allows you to use SamTrans and VTA buses as well. The monthly pass also includes unlimited travel on weekends.
- If you choose to use cash rather than a Clipper Card, take exact change for all buses, as bus drivers can't give change.



Buy your ticket from the machine at the station before boarding the train. It is not possible to pay on the train! The penalty fee for riding the train without paying is \$75.

If you are 18 years old or younger, or 65 years old or older, you may buy a discounted

ticket. However, you must carry official identification with your picture and birthdate on it to prove your age to the conductor on the train. If you don't have official identification with your picture and birthdate on it, buy a regular ticket.

• Clipper cards must have \$1.25 on them at all times and must be "tagged" by the card reading machine at the station at the beginning and end of the trip. Monthly pass holders do this just on the first trip of the month.

Health and Welfare


Insurance

Personal health insurance coverage is much less expensive than medical care in the US and is therefore **strongly recommended**. A 15-minute office visit to a doctor usually costs about \$300 without

medical insurance, and if a couple of simple medical tests are added, the cost can easily go up to \$1000. Accidents or serious medical problems can cost much, much more.

Acceptable health insurance must pay the majority of costs for basic and major medical situations, including hospital and emergency costs relating to illness and injury as well as medical evacuation and repatriation.

Students are not insured by Language Pacifica or by the host family against illness, accident, theft or any loss of personal effects. The school cannot accept responsibility for any accidents occurring during the course, on excursions, or during group activities.



Many students arrive with insurance from their home countries. Following are options

for those without insurance. The cost per month varies widely according to the student's age, the deductible (the amount you pay before the insurance company begins to pay), and the benefits. Payment of Tuition and Fees

Payment of tuition, registration, materials and textbooks is due by the first day of study. The 16-week rate is lowest, but it is fine to pay for shorter periods. Pay only for the number of weeks you know you'll study, as a twoweek penalty fee is subtracted from refunds. When a period is finished, payment for the next period is due.

Total charges for Full-time Intensive Program for students placing into Level 1 who want to complete Level 6 on time in 2019: \$27, 470.

Example total: Tuition for the 8-week Full-time Intensive English Program is: \$2430+ \$95 registration fee + \$15 materials fee + \$45 reading textbook + \$35 grammar textbook = \$2620 total.

You may pay by cash, check, credit card (Visa or Mastercard), money order, or bank wire transfer.

Cancellation and Refund Policy

Student's Right to Cancel: You have the right to cancel your agreement for a program of instruction, without any penalty or obligations, through attendance at the first class session or the seventh day after enrollment, whichever is later. After you begin classes, you have the right to stop school at any time and you have the right to receive a pro rata refund minus a cancellation fee. A written notice must be submitted to the office. Cancellation must be requested and approved.

Cancellation Prior to Start Date: If enrollment at Language Pacifica is cancelled prior to the class start date, all tuition paid will be refunded. The registration and homestay placement fees are not refundable. The airport transfer fee is refundable if cancellation is made more than 72 hours before the student's arrival.

Withdrawal after Course Start Date: Refunds are prorated, and a two-week cancellation fee is subtracted. (If cancellation is made just one week before the end of the paid tuition period, the cancellation fee is just the one week.) Refunds will be calculated on a weekly basis. When determining the number of weeks, a partial week will be considered the same as if a whole week were completed, provided the student was present at least one day during the scheduled week.

Example 1: Eight weeks of Full-time Intensive English (25 classes/week) Student paid: \$2620 (\$2430 tuition+ \$95 registration fee + \$15 materials fee + \$45 reading text + \$35 grammar text) Student cancels during Week 5. Only the tuition is refundable. For the refund, the seven-week rate is used (five weeks studied + two-week cancellation fee.) This is subtracted from the tuition paid. The refund is: \$2430 - \$2140 = \$290.

THE FEIDING IS. \$2430 - \$2140 - \$290.

Example 2: Four weeks of Part-time Intensive English (20 classes/week) Student paid: \$1290 (\$1100 tuition + \$95 registration + \$15 materials + \$35 grammar text + \$45 reading text) Only the tuition is refundable. Student cancels during Week 2. Because there is a two-week cancellation fee, there is no refund.

Example 3: Eight weeks of three classes per day (15 classes/week) Student paid: \$1895 (\$1740 tuition + \$95 registration + \$15 materials + \$45 reading text) Only the tuition is refundable. Student cancels during Week 3. For the refund, the five-week rate is used (three weeks studied + two-week cancellation fee.) This is subtracted from the tuition paid. The refund is: \$1740 - \$1120 = \$620.

Refund requests must be made in writing. Refunds will be paid or credited within 45 days of receipt of the written request.

The following statements are required by California law.

Financial Aid: Students at Language Pacifica are not eligible for federal or state financial aid programs. **Student Loans:** Language Pacifica students are not eligible for federal or state loans. However, there is a state requirement that the following information be posted in our school catalog: "If a student obtains a loan to pay for an educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund. If the student has received federal student financial aid funds, the student is entitled to a refund of the money not paid from federal student financial aid program funds."

Policies and Practices Regarding Any Form of Financial Aid: Language Pacifica students are not eligible for any form of financial aid through the school.

"NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION

The transferability of credits you earn at Language Pacifica is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the certificate you earn in Intensive English Program is also at the complete discretion of the institution to which you may seek to transfer. If the certificate that you earn at this institution is not accepted at the institution to which you seek to transfer, you may be required to repeat some or all of your coursework at that institution. For this reason you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending Language Pacifica to determine if your certificate will transfer."

(Please note that this is not connected to Language Pacifica's conditional acceptance program.)

"The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program."

"It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF may be directed to the Bureau for Private Postsecondary Education, 2535 Capitol Oaks Drive, Suite 400, Sacramento, CA 95833, (916) 431-6959 or (888) 370-7589.

To be eligible for STRF, you must be a California resident or are enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.

2. You were enrolled at an institution or a location of the institution within the 120 day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.

3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure. 4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.

5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.

6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.

7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.


To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of noncollection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number."

Prior Experiential Learning

Language Pacifica does not award credit for prior experiential learning. There are no assessments, policies or procedures, provisions for appeal, or charges for prior experiential learning.

The school consists of 8 classrooms surrounding an open lounge area that includes four computers for student use. Free WiFi is available throughout the building. There is a small kitchen with a snack machine, a cold drink vending machine, a hot drink vending machine, a hot water pot, two microwaves, a refrigerator, and a sink. The tap water is safe to drink.

Restrooms are located within the building, but outside our suite, and require a code—please ask for it at reception.

Emergency Procedure
