A notice of cancellation shall be in writing, and a withdrawal may be effectuated by the student's written notice to the school administrative office, 21515 Vanowen St., Ste. 100, Canoga Park, Ca., 91303 or by the student's conduct, including, but not necessarily limited to, a student's lack of attendance. The institution shall refund 100 percent of the amount paid for institutional charges, less an enrollment fee of \$150.

The institution shall issue a refund for unearned institutional charges if the student cancels an enrollment agreement or withdraws during a period of attendance.

The refund policy for students who have completed 60 percent or less of the period of attendance shall be a pro rata refund. No refunds are due once the student has received more than 60% of the clock hours of instruction in any given period of attendance.

The institution shall pay or credit refunds within 45 days of student's cancellation or withdrawal.

If the student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds.
