FACILITIES AND EQUIPMENT

American Health Education is located in the Sierra Trinity Business Park, 6761 Sierra Court, Suite G, Dublin, CA. The facility is approximately 4500 square feet with the office environment being clean and spacious. There are two (2) administrative offices and three (3) classrooms, a library with computer lab/learning resource area, copy machine, equipment rooms, records storeroom, two (2) cubicles for support staff. The classroom skills labs are outfitted with cardiac monitors, IV equipment and pumps, backboards, traction equipment, medical supplies, hospital gurney, ambulance gurney, manikins, AED's, two (2) ambulances and other equipment relative to nursing and emergency medical services profession.

We are conveniently located with easy access from 580 and 680 freeways and public transportation. We have plenty of parking spaces available for student parking and there is no parking fee.

PROGRAM DELIVERY/ENGLISH PROFICIENCY

All course content is delivered through the use of PowerPoint Slide directed lecture and is presented in English. The student must have the ability to read and write English at the level of a graduate of an American high school as demonstrated by the possession of a high school diploma, GED or passage of the California high school proficiency exam.

COURSE DESCRIPTIONS

EMT-Basic Description

The EMT-Basic Training Program offered by American Health Education fulfills all of the training requirements set forth by the State Of California in Title 22 of the California Code of regulations. The course curriculum includes all items outlined in Title 22, and is designed to guide students to successful completion of National Registry EMT-Basic Exam, which is required by the State of California for EMT- Basic licensure, and will allow students to work as an Emergency Medical Technician (SOC code 29-2041). Additionally, this course conforms to the National Standard EMT-Basic Curriculum formulated by the U.S. Department of Transportation. The course is divided into two sections: didactic instruction and skills training (160 hours) and supervised clinical experience (field ride-along 24 hours). Upon successful completion of all phases of training, a completion certificate will be awarded that will allow the student to apply for National Registry Certification and subsequent state licensure as an EMT-Basic.

Course Content – EMT-Basic

The American Health Education EMT-Basic program is designed on a modular basis and includes lecture, recitation, laboratory skills training, and externship.

Module 10 – National Registry and Comprehensive Finals Review is 16 hours and is a comprehensive review preparing the student for their upcoming Final Examinations and the National Registry Licensure Exam.

Module 11 – Final Written and Skills is 16 hours and tests the necessary skills and knowledge for licensure as an EMT-Basic.

National Registry Examination

To obtain EMT-Basic certification in the State of California, all students are required to pass the National Registry of EMT's Exam. The National Registry Exam consists of two parts – cognitive and psychomotor. To be eligible to take the National Registry Exam the student must successfully complete the following phases of the program:

- Didactic Phase – 160 hours
- Field Externship Phase – 24 hours minimum, with at least 10 patient contacts

Upon successful completion of all phases of the program, the student will be given a course completion certificate that will be used as proof of meeting the requirements to take the National Registry Exam. Once successfully completing the NREMT written/ cognitive examination, students will qualify to apply for State certification.

EMT-Basic Certification Requirements

The Emergency Medical Services Authority (EMSA) of California specifies requirements for EMT-Basic certification. Once you pass NREMT and receive your NREMT certification (valid for two years) you are eligible to apply to the local/county EMSA. Please check with your local county/state Emergency Medical Services Authority (<http://www.emsa.ca.gov/>) for other specific requirements and fees that may be required to practice as an Emergency Medical Technician in your area.

Monitor Technician Training Program Description (24 CE)

This four (4) day program provides an excellent opportunity for entry into or advancement within the healthcare field. A Monitor Technician fills an important role on the patient-care team by carefully watching patients' heart rhythms on monitors and alerting staff when abnormal rhythms are displayed. At the completion of these 4 days of intensive instruction you will have gained proficiency in the following: *Lead Placement for Telemetry Monitoring * Basic EKG Interpretation * Advanced Arrhythmia Recognition and * Communication Skills on the Healthcare Team. A competency based certificate will be issued for successful completion of course which will allow students to pursue a career as a Monitor Technician (SOC code 29-2031).

Continuing Education Course Description

Continuing Education courses are offered to licensed healthcare providers. Each course description includes the date and the number of continuing education (CE) contact hours for the course. Students must complete each course in its' entirety and credit for completing part of a course may not be granted. Thus, if a person attending the course leaves before the course is over, the certificate of completion cannot be issued. Upon completion of the course, the student will receive a certificate of completion with the number of continuing education contact hours. The certificate must be retained by the licensee for a period of four years after the course ends. Courses may be rescheduled or cancelled in the event of low enrollment or instructor emergencies. Course hours: 9:00 a.m. to 4:30 p.m.

ACLS Preparation Course (6 CE)

This course is for individuals who are interested in successfully completing an American Heart Association Advanced Cardiac Life Support provider course. This workshop provides basic ACLS knowledge and assessment skills, reviews cardiac electrical conduction system, and includes recognition of life threatening dysrhythmias, cardiac pharmacology, and insertion techniques for various airway devices used in ACLS.

Cardiac Drugs and Drips (6 CE)

Pharmacological management of hypertension, myocardial infarction, heart failure, atrial and ventricular arrhythmias is the focus of this program. Drug classifications (and their physiologic actions, indications, dosages, combination therapies, adverse reactions and nursing interventions) include: * Antiarrhythmics * Diuretics * Calcium channel blockers * Thrombolytics * IIb, IIIa agents, Anticoagulants* Anti-hypertensives and * Beta-blockers.

Course date: February 10, 2018

Cardiovascular Nursing: Medical Perspective (6 CE)

This program presents an overview of unstable angina, acute MI, management of CHF and includes a discussion of interventional cardiology procedures such as angioplasty, atherectomy, stents, plus a discussion of pacemakers and implanted defibrillator management are addressed.

Course date: February 16, 2018

Cardiovascular Nursing: Surgical Management (6 CE)

If you are a nurse who cares for patients with cardiovascular and/or peripheral vascular disease, you will want to attend this course. Emphasis is on acute nursing management following open-heart surgery including CABG and valve replacement as well as acute medical and nursing interventions for the patient with carotid, peripheral vascular and aortic disease.

Course date: February 24, 2018

Collaborative Management: Putting It All Together Part 1 & 2

(Formerly RN Skills Day)

Collaborative Management will provide the medical-surgical nurse with a 2-day review of fundamental skills & tools vital to recognizing physiological changes. Is my patient's condition deteriorating? Should I notify the Rapid Response Team to affect a timely "rescue"? Participants will encounter imminent situations and perform assessments and interventions as a team to prevent or reduce the effect of adverse events in various combined settings of: chest discomfort, anaphylaxis, sepsis, hypotension, hypoglycemia, altered level of consciousness, and post-op complications. Practicum subject to change at Instructors discretion.

Communicating Effectively and Understanding Diversity (6 CE)

As a prelude to re-entering the nursing field, it is important to understand yourself and how you interact and communicate with others. In this class, you will learn to communicate in an effective and timely way with others. You will learn to choose ways to clear up misunderstandings, diffuse your anger and frustration and strategize how to work with difficult people. You will also come to understand how to identify, maneuver and embrace differences.

Course date: January 9, 2018

EKG Rhythm Identification – (12 CE)

This 12-hour course is designed to provide a comprehensive study of basic cardiac arrhythmia identification. We will begin at the very basic level of cardiac anatomy. Learn to read an EKG strip, determine what the normal components of the EKG waveform are, examine the basic cardiac dysrhythmias, and increase your knowledge of the causes and treatments of cardiac arrhythmias. This course is ideal for RNs, LVNs, Paramedics and EMTs looking to increase their cardiac clinical competency. The BRN does not recognize CE's for RNs for this class, therefore RNs will receive a completion certificate.

Course date: January 18 & 19, 2018

Forensic Nursing and Medico-Legal Investigation (6 CE)

Come and explore this is exciting new area of nursing which combines legal and scientific investigation skills with aspects of healthcare related to patients who have been the victims of trauma, abuse or violence. Study actual cases and learn how the team functions in a modern

investigation. This is a fascinating and enlightening new area of nursing you won't want to miss! (The final 45 minutes will be a video of a medico-legal autopsy. **BE ADVISED**—photographs and video are graphic and very disturbing-this program ***is not*** for those with tender sensibilities.)

Geriatric Focus / Critical Thinking (6 CE)

Geriatric Focus: HCPs must commit to intervene at multiple levels by assessing precise health risks and follow progress to ensure need-goals are realized. This class will present ongoing concerns with aging and evidence-based interventions adapted to diverse populations and settings. Critical Thinking: Do you constantly question your own method of reasoning? Nurses are perpetually involved in complex significant questions affection their patients. Critical inquiry is an imperative to sound reasoning, and sound reasoning is an imperative to the delivery of safe and effective care. What skills and abilities have nurses developed for sound reasoning?

Course date: February 1, 2018

GI and Renal Systems Review (6 CE)

Review of the anatomy and pathophysiology of the renal system and major organs of the GI tract; nursing management of GI bleed, cirrhosis, acute renal failure, pancreatitis, diabetic ketoacidosis, HHNK, SIADH. Includes optional autopsy video of these systems.

Course date: March 24, 2018

Hemodynamic Monitoring, Applied (6 CE)

Directed toward nurses with a working knowledge of invasive pressure monitoring who wish to expand their application of those principles, you will correlate hemodynamic measurements with underlying pathophysiology in patients with hypovolemia, cardiogenic shock, anaphylactic shock, neurogenic shock and sepsis, and discuss appropriate vasoactive drips as interventions.

Course date: March 3, 2018

Hemodynamic Monitoring, Basic (6 CE)

Basic concepts and techniques of hemodynamic monitoring, emphasis on nursing management and interpretation of hemodynamic data obtained from a pulmonary artery catheter and problems with invasive monitoring.

Course date: March 2, 2018

IV Therapy Review (6 CE)

This day is designed to re-orient you to IV solutions, management of blood and blood products, PICC, central lines, ports and safe needle devices. We will review current standards and practices as recommended by the IV Nurses Society for fluid administration, flushing IV lines, blood withdrawal from central lines as well as care and maintenance of peripheral and central lines.

Course date: January 17, 2018

Legal Ethics And Patient Safety (6 CE)

What is negligence? When does negligence ripen into liability? What is malpractice? Which strategies to employ in order to prevent a charge of either? Understand and apply health care ethics to stay in compliance with health care laws. Learn the practice of risk assessment and priority setting in a continuum. The Patient Safety Initiatives class will explain the legal, ethical and socioeconomic basis for contemporary regulations & evidence based practice: Failure to Rescue, Rapid Response Teams, Core Measures, Root Cause Analysis, Hospital-acquired infections, HIPAA, Informed Consent, Advanced Directives, Patient Education and Empowerment, and much more.

Course date: January 12, 2018

Monitor Technician Training Program (24 CE)

This four (4) day program provides an excellent opportunity for entry into or advancement within the healthcare field. A Monitor Technician fills an important role on the patient-care team by carefully watching patients' heart rhythms on monitors and alerting staff when abnormal rhythms are displayed. At the completion of these 4 days of intensive instruction you will have gained proficiency in the following: Lead Placement for Telemetry Monitoring, Basic EKG Interpretation, Advanced Arrhythmia Recognition and, Communication Skills on the Healthcare Team. A competency-based certificate will be issued for successful completion of course which will allow students to pursue a career as a Monitor Technician (SOC code 29-2031).

Course date: April 2, 3, 4, 6, 2018

Neuro Basics For Critical Care (6 CE) (Formerly Neuro System Overview)

A review of the Nervous System anatomy and pathophysiology, basic neuro assessment, correlating neurological conditions with assessment findings, treatment options, and nursing interventions. Discussion of skull fractures, meningitis, hydrocephalus, seizures, strokes, intracranial hemorrhage and increased intracranial pressure.

Course date: March 17, 2018

Neurovascular Conditions and Diabetes in Acute Care (6 CE)

(Formerly Care of the Stroke Patient)

This program will provide care strategies for traumatic brain injury, seizures, and encephalopathy, with emphasis on stroke care per Joint Commission core measures. Diabetes in Acute Care: Discussion of guidelines for hyperglycemic crises, the dilatory effects of hyperglycemia on recovery, and the principle of tight glycemic control.

Course date: January 29, 2018

Respiratory Assessment (6 CE)

Come learn the key concepts and skills needed to perform a complete and comprehensive assessment for patients with respiratory disease. Content includes the collection of nursing history, physical assessment, ABG interpretation and technological adjunct data used to formulate a nursing care plan for the respiratory patient. Please review basic respiratory anatomy and physiology prior to the class.

Course date: March 9, 2018

Respiratory Care Update (6 CE) (Formerly Adult Physical Assessment Overview)

In this course, we will discuss pulmonary circulation, the courses of respiratory insufficiency as well as conditions that require supplementary oxygen administration. We will review how to conduct a respiratory assessment use the 9-region approach to assessing breath sounds. We will discuss the use of pulse oximetry and wave form capnography in clinical setting. A review of respiratory equipment and supplies will be provided. We will also discuss the function of the kidney. We will review chronic renal and the role of dialysis and an overview of dialysis shunts. We will discuss clinical situations and events that require isolation in the healthcare setting and review various types of isolation and the appropriate Personal Protective Devices.

Course date: January 18, 2018

Spanish For Health Care Providers: Basic-Level I (6 CE)

Do you ever wish you could communicate immediately with your Spanish-speaking patients without waiting for an interpreter? If so, join us to increase your Spanish skills: medical terminology, commands, conversation and grammar. Previous Spanish not required.

Course date: April 27, 2018

Spanish For Health Care Providers: Level II (6 CE)

This program builds on the skills you acquired in Spanish Level I and simplifies language barriers through role-playing of common hospital situations. Areas of focus include: consulting, medical history, common illnesses, and Intercultural communication. It is recommended that you have completed Spanish Level I or have previous basic Spanish language experience.

Spanish for EMS Providers (6 CE)

Take it to the streets! This dynamic and fun class has been developed specially to provide firefighters/paramedics/EMT's and ER personnel with the basic level Spanish at an emergency scene. Curriculum includes: pronunciation, basic grammar structure, helpful medical phrases, tips on how to control communication, role playing, understanding the Latino perspective regarding health and safety. No previous Spanish is required.

Course date: April 20, 2018

Ventilator Workshop, Basic (6 CE)

The benefits of this comprehensive overview of nursing care for the mechanically ventilated patient include: respiratory assessment, basic types of mechanical ventilation, trouble-shooting, weaning and ventilator emergencies. Case studies are used to apply principles to practice.

Course date: March 10, 2018

Wound Care (6 CE)

This day is devoted to advances in the care of wounds and wound healing. Because all wounds are unique, care must constantly be re-evaluated throughout the healing process. Increase your clinical competency as you learn prevention, assessment of patients at risk, and the rationale for choices of treatment and dressings.

Course date: January 22, 2018

EDUCATIONAL OBJECTIVES

The *EMT-Basic* program is based upon the California EMS Authority and the National Registry of Emergency Medical Technicians and adhere to the Department of Transportation's National Standard Training Curricula:

- To develop the EMT-B student to understand what it means to be an EMT-B. This includes the career field of Emergency Medical Systems and the Roles and Responsibilities of the EMT-B in the EMS field.
- To provide the EMT-B student the knowledge, skills, and ability to provide top level care and function safely and effectively in the pre-hospital environment.
- The EMT-B student will be able to demonstrate competency and proficiency in both basic EMT skills with each patient he/she will encounter.
- To prepare the EMT-B student to successfully complete the National Registry Licensure Examination.

Monitor Technician

- To equip students with the knowledge, skills, and competencies to successfully complete the Monitor Technician training program.
- The program is committed to preparing students for the responsibilities as a Monitor Technician to provide quality patient care and dedicate themselves as medical professionals in the community they serve.

Continuing Education

- To provide courses related to direct/indirect patient care that enhance knowledge and technical skills required for practice at a level above that required for licensure.

ADMISSION REQUIREMENTS

EMT-Basic: To qualify for this program, each applicant must have:

- High school diploma, GED Certificate or equivalent
- American Heart Association Basic Life Support Certification (CPR)
- Current Immunization Records for:
 - ✓ TB- Tuberculosis within 1 year
 - ✓ Tetanus within 1 year
 - ✓ MMR- Measles, Mumps, Rubella (childhood record OK)
 - ✓ Varicella Immunity
 - ✓ Hepatitis B- At least shot #1 in series
- Current California ID/Driver's license
- Current Healthcare Insurance card

Monitor Technician: To qualify for this program, each applicant must have:

- High school diploma, GED Certificate or equivalent
- Current California ID/Driver's license

If you are taking the course for continuing education you must provide a copy of your healthcare provider license.

Continuing Education: To qualify for Continuing Education program, each applicant must have:

- Proof of current healthcare provider license or certificate.

EDUCATIONAL PREREQUISITES

EMT-Basic: This program requires that all students possess a current high school diploma or GED certificate or equivalent.

- Physical considerations: EMT-Basic students must possess sufficient ability to: Lift at least 50 lbs unassisted, stand, carry and balance on uneven terrain. Stoop, kneel, climb, crouch and crawl as needed to reach patients and safely remove and transport. Carry and utilize emergency medical equipment appropriately. Communicate verbally to patients, physicians, nurses and co-workers. Hear, understand and react quickly to verbal instructions and patient needs. In addition, students must be able to travel to clinical sites as assigned and work varying shifts and hours as assigned.

Monitor Technician: This program requires that all students possess a current high school diploma or GED certificate or equivalent. If you are taking the course for continuing education you must provide a copy of your healthcare provider license or certificate.

Continuing Education: Student must possess a current healthcare provider license. For verification of specific course approval, please contact your accrediting agency to confirm continuing education requirements.

APPLICATION PROCESS

All interested applicants must submit a completed application along with a \$75.00 non-refundable application fee (EMT-Basic only). Upon acceptance and approval of the application, the applicant will be invited to tour the facility and discuss program information. The enrollment agreement will be executed during orientation or on the first day of class. All required registration fees and documents must be provided as listed in the enrollment agreement. AHE does not provide VISA services for foreign students, therefore, you must be eligible to study in the United States to enroll.

ENROLLMENT AGREEMENT

Students must sign an enrollment agreement before beginning a course at AHE. The agreement includes information pertaining to tuition and fees, attendance, course details- dates, location, time, STRF fees, cancellation, course certificates, transferability, and other related matters.

STANDARDS OF SATISFACTORY ACADEMIC PROGRESS

ACADEMIC STANDARDS

In order to maintain enrollment in the classroom or didactic phase of training, a student must maintain the following:

1. A cumulative average of minimum of **eighty percent (80%)** on all examinations, quizzes and assignments administered throughout the entire classroom program.
2. No more than **(3) examinations scores below 80%**.
3. Complete and pass all skills assignments or skills testing. (EMT-B)
4. Complete final with a passing (minimum 80%) score

5. Complete skills finals stations with a passing score. (EMT-B)
6. Students may repeat a skills station only once and only under the approval of the Program Director. (EMT-B)

GRADING SCALE

AHE uses a standard grading scale for all tests and quizzes. All cumulative grades must be kept above the National Standard Minimum Acceptable Grade of 80%. All grades will be based on the following grading scale:

- **Didactic Grading Scale**
 - 100-90 = A
 - 89-80 = B
 - 79-70 = C
 - <70 = F

- **Clinical Grading Scale (EMT-B)**
 - The clinical time for EMT-B is observational time only and consists of a minimum of 24 hours and ten patient contacts. No letter grade is given.

Maximum Allowable Time Frame

The maximum allowable time frame for completion of an EMT-Basic program is 150% of the total time of the program. If a student feels that he or she is going to exceed the maximum allowable time of the program, it is the **RESPONSIBILITY OF THE STUDENT** to notify the school immediately to discuss the issue(s) pertaining to the timeframe and to establish a plan for completion of the program. The student will be required to make an appointment with AHE administration and enter into a Performance Improvement Plan (PIP) agreement. The PIP will be a signed agreement between AHE and the student and will list the expectations in order to obtain a course completion certificate. If the student does not meet the expectations set forth in their Performance Improvement Plan, he/she will be dismissed from the program.

Continuing Education Course- Students must complete each course in its' entirety and credit for completing part of a course may not be granted. Thus, if a person attending the course leaves before the course is over, the certificate of completion cannot be issued. Upon completion of the course, the student will receive a certificate of completion with the number of continuing education contact hours.

TARDINESS, ATTENDANCE AND MAKE UP WORK

Students shall be required to attend a minimum number of training hours in order to be eligible for successful completion of an AHE training program. Unexcused or excessive absences, tardiness, or early departures from an AHE training program shall be grounds for immediate program dismissal.

1. All training programs shall have a minimum number required hour, which all students must attend in order to successfully complete a course of instruction.
2. Minimum required training hours shall be identified by the instructor and communicated to the student prior to or during the enrollment process.
3. Three (3) unexcused absences, (3) unexcused tardiness, or (3) early departures (instances where student leaves prior to being dismissed by instructor) shall be grounds for immediate dismissal from the training program.

4. Unexcused for the purposes of this policy shall be defined as where AHE has not received written or verbal information; or where the student has not made contact to advise of the circumstances and received acknowledgement and/or approval regarding the absences, tardiness or early departures.
5. Excessive absences where the student has missed more than ten percent (10%) of the total scheduled class time shall be grounds for immediate program dismissal from the training program.
6. This policy shall include any unexcused absence, tardiness, or early departure for which the student was previously scheduled to attend as part of their classroom, clinical or field training.
7. It is the responsibility of the student to make arrangements with the instructor to make up all work and training missed while absent or tardy.

PROGRAM WARNING, PROBATION, SUSPENSION & DISMISSAL

AHE may issue an academic, attendance or behavioral warning, probation, or suspension to students as a process for remediation or conditions for continued enrollment in a training program.

1. Students who do not meet the academic, attendance, or behavioral standards of AHE may be subjected to the following process prior to program dismissal;
 - **First infraction**: student may be issued a written or verbal warning advising of their potential failure to meet standards.
 - **Second infraction**: student may be placed on written or verbal probation, which shall have conditions that must be met by the student in order to continue enrollment in training program.
 - **Third infraction**: student will be involuntarily dismissed from training program.
2. In order for the student to be removed from probation and placed on regular status, he/she must be able to demonstrate that the behavior, incident, and/or cause of the warning or probation has been corrected and all conditions set forth in their written or verbal probation have been met.

STUDENT CONDUCT

Students enrolled in training programs offered or sponsored by AHE shall adhere to a code of conduct in all phases of training that shall include but not be limited to the following:

1. Report to all training sessions on time.
2. Attend all training sessions until completed or dismissed by instructor.
3. Respect the rights of all instructors and fellow students to have a learning environment that is conducive and free of distractions.
4. Actively participate in all training sessions.
5. Criticize ideas and concepts but not people.

DISMISSAL

Conduct which shall be grounds for immediate dismissal or suspension (until an investigation or trial has been concluded) from AHE training programs include but is not limited to the following:

1. Disregard for AHE student policies and procedures.
2. Cheating or alleged cheating.
3. Falsification of documents or property.
4. Misrepresentation of property or work.
5. Excessive absenteeism.
6. Insubordination.

7. Defiance of authority.
8. Reckless disregard for safety.
9. Suspected or actual drug or alcohol use while participating in AHE activities; classroom sessions, skills sessions, clinical or field rotations.
10. Suspected drug or alcohol abuse.
11. Discrimination of age, gender, race, handicap, or sexual orientation.
12. Assault or battery.
13. Theft or robbery.
14. Sexual assault or harassment.

AHE reserves the right to immediately dismiss any student for conduct or behavioral issues that are illegal or present immediate danger to others. Action to suspend or dismiss a student by AHE may be based upon accusations or allegations and may be in the form of an immediate written or verbal suspension until appropriate jurisdictional authorities have concluded an investigation and deliberation of charges. Students may be held accountable for actions or accusations brought against them from incidents or the actions; or from authorities outside and not affiliated with AHE. Students may be given a warning or counseling session prior to dismissal only at the discretion of the AHE Program Director. Students suspended from an AHE program shall **continue to be responsible for all financial and tuition obligations** until such time as a decision has been made regarding the continuance or dismissal of the student. Students who are dismissed from an AHE program for conduct shall be eligible for tuition refund. (See *Program Cancellation, Withdraw and Refund*).

LEAVE OF ABSENCE

Students may apply for a “leave of absence” (LOA) when unforeseen circumstances arise disrupting the student’s ability to continue during the training process. Students may be eligible for a LOA if they meet the following criteria:

1. The student can document and demonstrate a personal, mental, physical, medical or financial hardship, which disrupts the student’s ability to continue with their training. This includes US Military active and reserve for acts of war or civil defense and Jury Duty.
2. The student is in good academic and conduct standing with AHE.
3. The student is current with required tuition and fee payments.

LOA’s shall be granted exclusively at the discretion of the Program Director. LOA’s shall be for a maximum ninety-day time period. LOA will not be granted for continuing education courses or courses/programs that are 10 days or less in duration. The Program Director may consult and seek recommendations regarding LOA’s from the Quality Review Board. Students who are granted a LOA shall continue to be officially enrolled in an AHE training program and shall continue to meet the financial or tuition requirements for their original training program. The student shall be fully responsible for all conditions, timelines, and deadlines of the LOA. If the student fails to return from the LOA on the date indicated the student will be terminated and the Cancellation/Refund policy will apply.

Procedure

1. The student must request a LOA in writing to the Program Director prior to missing any assigned or regularly scheduled didactic, clinical or field shifts. An emergency extension of this deadline may be granted only at the sole discretion of the Program Director.
2. The Program Director in consultation with the Quality Review Board shall make a decision to grant or not to grant the LOA within a maximum of ten (10) days from the receipt of the written request.
3. The student shall receive a “**Written Notification of Leave of Absence**” in writing which shall include the decision, conditions and length of LOA.
4. If AHE does not receive a rejection of LOA from the student in writing within fourteen (14) days from the date listed on the **Written Notification of Leave of Absence**, the LOA period and conditions shall be considered effective.
5. The student shall be responsible for fulfilling all conditions of the LOA.
6. The student shall be responsible for contacting the school in writing to advise of readiness to re-enter the program within thirty (30) days of the LOA expiration.
7. Students who are granted a LOA based upon medical conditions must have a medical release showing “physically fit to return to duty” in writing and signed by the treating or primary medical doctor.
8. Upon receipt of notification by student to school of readiness to re-enter, a student assessment process will be implemented by AHE.
9. The returning student may be tested and assessed by AHE faculty to identify the best possible insertion point into the program.
10. A program of re-entry will be developed for the student by AHE which may require additional didactic, clinical and field time up to the maximum of their original training program requirements.
11. The student may be responsible to purchase a new textbook if during their LOA the program adopted a new edition of textbook.
12. All written correspondence to and from the student shall be by U.S. Mail and shall be certified with return receipt requested.
13. In all cases, students shall not be held accountable for failure to contact AHE, if the student can show by way of U.S. certified mail receipt or documented electronic transmissions that attempts have been made to communicate during the specified period at the following mail address:

14. In the case that the student has not responded to conditions or timelines associated with the LOA, or when the school has not been able to contact the student, or when the student has not contacted the school (AHE) within thirty (30) days prior or thirty days (30) after the LOA expiration deadline, this shall be considered sufficient grounds for immediate student dismissal from the training program.

15. Failure to meet the written conditions of the LOA or to complete written re-entry program requirements as specified by AHE staff upon re-entry, shall be grounds for immediate program dismissal from the training program.
16. If a student fails to return from a LOA, the student's last recorded date of attendance is considered the withdraw date. If any, a refund will be dispersed to the student according to the CEC Section 94920. (See *Program Cancellation, Withdraw and Refund*).

PROGRAM REINSTATEMENT

Students who have been previously enrolled in a program at AHE but have since been dismissed or terminated by the school or who have withdrawn voluntarily may be reinstated into their previous program in advanced standing. The reinstatement must occur within thirty (30) days or the student must start at the beginning of a new program. Reinstatement will not be granted for continuing education courses or courses/programs that are 10 days or less in duration. In order for a student to be reinstated into a previous program or in advanced standing, the student must meet the following requirements:

1. Student must be in good standing with the school, which includes but is not limited to the following:
 - Student has paid all outstanding fees and tuition.
 - Student has submitted all required documentation and immunizations
 - Student is not accused of or under investigation for a criminal offense.
 - Student has not been convicted of a criminal offense, which would preclude eligibility for state licensure as an EMT.
 - Student has maintained good conduct.
 - Student has been cleared by a California licensed physician as physically capable of performing typical duties and activities of an EMT.
2. Student must complete a new application and pay the application fee (\$75.00).

APPEALS

Students who have been dismissed from training programs or who have received notification of disciplinary or academic warning or action or probation may appeal this action to the program director of AHE and request a confidential hearing.

1. Appeals must be in writing and submitted either in person or by mail to the Program Director within thirty (30) days from the date of which action was taken.
2. All appeals will be evaluated by the Program Director in consultation with the Medical Director.
3. The appeal hearing shall be set up and commence within 15 business days of the day from which the student requested a hearing.
4. Students who fail to attend the appeal hearing shall have the appealed action sustained and continued in full force without future recourse.
5. The participants in the hearing shall consist of the Quality Review Board.
6. The student shall have an opportunity to address the hearing board and to present any and all forms of documentation and references.
7. The appeal hearing board shall listen to the student appeal and render a recommendation to rescind, modify or sustain the action.

8. The final decision to rescind, modify or sustain the action shall be at the sole discretion of the Quality Review Board.
9. The student shall be notified of the final decision regarding the appeal in writing within 5 business days after the date of the appeal hearing.

STUDENTS RIGHT TO CANCEL

CANCELLATION, WITHDRAWAL, AND REFUND

The student has the right to cancel and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later. If you choose to cancel this agreement, AHE will refund any money that you paid less specified non-refundable fees. Cancellation shall occur when you give written notice of cancellation addressed to Program Director and sent by US certified mail, facsimile, or hand delivered. The written notice of cancellation is effective on the date received by AHE. The refund will be issued within 45 days of the notice of cancellation.

AHE follows refund guidelines set by the Bureau for Private Postsecondary Education in accordance with 5 CCR 71750. You have the right to withdraw from a course of instruction at any time. If you withdraw from a course of instruction after the period allowed for cancellation of the agreement set forth above, AHE will issue a pro-rata refund for students who have completed 60 percent or less of the period of attendance. The pro-rata refund will be calculated as follows: total institutional charge divided by the number of days in the program, multiplied by the number of days student attended, or was scheduled to attend prior to withdrawal, less the amount paid by the student. All amounts paid in excess of what is owed as calculated above shall be refunded within 45 days of the student's withdrawal or cancellation.

If the student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds.

CANCELLATION INITIATED BY THE STUDENT

Procedure:

1. Students who are eligible for a tuition refund must first notify the school in writing of their intent to cancel the agreement or withdraw from the program.
2. Notification shall be made in writing and must be signed by the enrolled student.

PROGRAM OR CLASS CANCELLATION INITIATED BY AHE

It is the policy of AHE to give a full refund of all fees and tuition for any training class or program that is cancelled by AHE administration. Students who have paid any part of their tuition are eligible for a tuition refund and will receive a refund of all tuition automatically within ten (10) business days of notification of cancellation.

STUDENT SERVICES

TUTORING

Student is advised that AHE has academic tutoring for those students who feel they need it. The cost is \$50/hour with a two-hour minimum.

HOUSING

- A. AHE does not have any dormitory facilities under its control.
- B. In the Dublin area, room rentals start at about \$950 per month and one-bedroom apartments rentals are approximately \$1890 per month.
- C. AHE has no responsibility to assist a student in securing student housing.

FINANCIAL AID

Student is advised that AHE does not participate in any Federal or State financial aid program. If the student obtains a loan to pay for this educational program, the student has the responsibility to repay the full amount of the loan plus interest, less the amount of any refund. If the student receives federal student financial aid funds, the student is entitled to a refund of the money not paid from federal financial aid funds.

AHE does not require disclosure of the funding source.

If the student defaults on a federal or state loan the following may occur:

1. The federal or state government or a loan guarantee agency may take action against the student, including garnishing an income tax refund; and
2. The student may not be eligible for any other government financial assistance at another institution until the loan is repaid.

LEARNING & PHYSICAL DISABILITIES

All facilities at AHE are handicap accessible and AHE complies with the Americans with Disabilities Act (ADA) of 1990 and Section 504 of the Federal Rehabilitation Act of 1973. Applicants who are persons with disabilities may apply for admittance into the program. AHE will work with the applicant or student to determine whether reasonable accommodations can be effective and/or are available.

The computer allows students to use technology when learning and studying. The online resource provides an inter-active approach for the student that aids in retention of the subject matter. STUDENT TUITION RECOVERY FUND

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program.

It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF may be directed to the Bureau for Private Postsecondary Education, 2535 Capitol Oaks Drive, Suite 400, Sacramento, CA 95833, (916) 431-6959 or (888) 370-7589.

To be eligible for STRF, you must be a California resident or are enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
2. You were enrolled at an institution or a location of the institution within the 120 day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.
3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of non-collection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number.

TRANSFERABILITY

NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION

The transferability of credits you earn at American Health Education is at the complete discretion of an institution to which you may seek to transfer. ACLS Preparation Course (6 CE)

~~This course is for individuals who are interested in successfully completing an American Heart Association Advanced Cardiac Life Support provider course. This workshop provides basic ACLS knowledge and assessment skills, reviews cardiac electrical conduction system, and includes recognition of life threatening dysrhythmias, cardiac pharmacology, and insertion techniques for various airway devices used in ACLS.~~

All in the Abdomen (6 CE)

This program provides guidelines for assessing and managing the care of patients with gastrointestinal conditions: mesenteric ischemia, GI bleed, pancreatitis, cirrhosis. Also included: banding, sclerotherapy, paracentesis and TIPS.

Cardiac Nursing (6 CE)

This program provides the tools to assess signs and symptoms of cardiac disorders including acute coronary syndrome, myocardial infarction and congestive heart failure.

Collaborative Management: Putting It All Together Part 1 & 2 (12 CE)

Collaborative Management will provide the medical-surgical nurse with a 2-day review of fundamental skills & tools vital to recognizing physiological changes. Is my patient's condition deteriorating? Should I notify the Rapid Response Team to affect a timely "rescue"? Participants will encounter imminent situations and perform assessments and interventions as a team to prevent or reduce the effect of adverse events in various combined settings of: chest discomfort, anaphylaxis, sepsis, hypotension, hypoglycemia, altered level of consciousness, and post-op complications. Practicum subject to change at Instructors discretion.

Mechanical Ventilation (6 CE)

Evidence-based patient/ventilator management in the ICU and E.D. for Respiratory Therapists, Critical Care RN's and Nurse Practitioners. Topics include: respiratory failure and the need for mechanical ventilation, ventilator waveform interpretation, respiratory mechanics, evidence based mechanical ventilation strategies for obstructive and restrictive disorders, ARDS, patient/ventilator asynchrony, noninvasive ventilator support, respiratory muscle fatigue avoidance, and predicting readiness for extubation.

Course date: August 3, 2018

Medical Terminology (6 CE)

Are you interested in improving your medical terminology skills? This program is for you! Learn the language of healthcare by attending this one-day workshop. This program will teach you how to read and understand medical terms that appear on charts and in literature. Don't miss this opportunity to improve your skills in learning and pronouncing medical terms.

Course date: August 9, 2018

Neurovascular Conditions and Diabetes in Acute Care (6 CE)

This program will provide care strategies for traumatic brain injury, seizures, and encephalopathy, with emphasis on stroke care per Joint Commission core measures. Diabetes in Acute Care: Discussion of guidelines for hyperglycemic crises, the dilatory effects of hyperglycemia on recovery, and the principle of tight glycemic control.

Neuro Basics For Critical Care (6 CE)

A review of the Nervous System anatomy and pathophysiology, basic neuro assessment, correlating neurological conditions with assessment findings, treatment options, and nursing interventions. Discussion of skull fractures, meningitis, hydrocephalus, seizures, strokes, intracranial hemorrhage and increased intracranial pressure.

Neurological Syndromes and Management (6 CE)

This course provides an interactive case study review of common neurological syndromes seen in Critical Care. Focus is on the students' application of topics presented in Neuro Basics for Critical Care- skull fractures, meningitis, hydrocephalus, seizures, strokes, intracranial hemorrhage and increased intracranial pressure.

Post-Op Complications, Sepsis and Shock (6 CE)

Critical thinking is vital for the early recognition and treatment of post-op complications. Nurses need to understand the surgical procedure, anesthesia, inherent risks, as well as a patient's co-morbidities to anticipate potential problems, perform focused assessments, and proactively

manage the patient's care. This program will clarify normal cardio-respiratory, gastrointestinal, renal, immunological, neurological, and circulatory physiology, and the alterations in physiology produced by surgical stress.

Respiratory Care Update (6 CE) (Formerly Adult Physical Assessment Overview)

~~In this course, we will discuss pulmonary circulation, the courses of respiratory insufficiency as well as conditions that require supplementary oxygen administration. We will review how to conduct a respiratory assessment use the 9-region approach to assessing breath sounds. We will discuss the use of pulse oximetry and wave form capnography in clinical setting. A review of respiratory equipment and supplies will be provided. We will also discuss the function of the kidney. We will review chronic renal and the role of dialysis and an overview of dialysis shunts. We will discuss clinical situations and events that require isolation in the healthcare setting and review various types of isolation and the appropriate Personal Protective Devices.~~

Respiratory Care Update (6 CE)

The goal of this program is to update the RN's knowledge & skill in the care of patients with respiratory compromise. Topics include: causes and treatment of atelectasis, pleural effusion and pulmonary edema; management of chest drainage system; pleurodesis, decortication and video-assisted thoracoscopy (VATS); basic ventilatory settings; prevention of ventilator acquired pneumonia; and respiratory isolation.

The Respiratory Patient—Eval and Treat (6 CE)

A systematic approach to the assessment of patients with acute and chronic respiratory disorders. Topics include: oxygen therapy and blood gas interpretation, respiratory emergencies, pharmacology and evidence-based treatment strategies to improve patient outcomes. This continuing education course is intended for Respiratory Therapists, RNs, and Nurse Practitioners.

Course date: August 2, 2018

Sepsis: Killing Me Softly (6 CE)

This course will define the sepsis pathology and the current sepsis survival guidelines. We will address failure to rescue: the problems in early detection and timely implementation of the guidelines. We will recognize the susceptible patient in specific areas. We will practice team collaboration in sepsis vignettes.

Shock States and Bedside Emergencies (6 CE)

This course will provide the med-surg RN with information on the recognition & treatment of shock states (neurogenic, hypovolemic, cardiogenic, septic, & anaphylactic). Case studies will illustrate pathophysiology, assessment, diagnosis, and treatment. Also included in this format are delirium, acute renal failure, hyponatremia, diabetic ketoacidosis, as well as post-op complications of myocardial infarct, arrhythmias, stroke, and malignant hyperthermia.

Spanish for EMS Providers (6 CE)

Take it to the streets! This dynamic and fun class has been developed to provide firefighters/paramedics/ EMT's and ER Personnel with the basic level Spanish at an emergency scene. Curriculum includes: pronunciation, basic grammar structure, helpful medical phrases, tips on how to control communication, role playing, understanding the Latino perspective regarding health and safety. No previous Spanish is required.

Trauma Management Basics (6 CE)

In this one-day class students will learn the basics of trauma management by learning specific nursing responsibilities for the trauma patient, demonstrating in-class patient scenarios, primary and secondary assessment survey, and verbally correlating rationale supporting critical thinking specific to trauma care.

Course date: August 23, 2018

RN Refresher Nursing CE Course (72 CE)

If you have been out of nursing for a year or more then this course is for you! The 12-day course provides you with an update on the most important areas of acute care and includes the following one-day CE classes: All in the Abdomen, Cardiac Nursing, Collaborative Management: Putting It All Together Part 1 & 2, Critical thinking and Communication, Geriatric Focus and Renal Update, IV Therapy Update, Respiratory Care Update, Legal Ethics and Patient Safety, Neurovascular Conditions and Diabetes in Acute Care, Post-Op Complications, Sepsis and Shock, Wound Care. Course includes voucher for Basic Life Support (BLS) class. A RN Refresher Nursing CE completion certificate is provided upon completion of all 12 days.

Critical Care Nursing CE Course (60)

This 10-day course is designed to provide the theoretical foundation to enable nurses to transition to Critical Care Nursing in a precepted environment. If you are a RN with no previous experience in Critical Care Nursing or if you need a review, this course is for you.
