STUDENT'S RIGHT TO CANCEL

A student has the right to cancel the enrollment agreement and obtain a refund of charges paid through the first class session or seven days after enrollment whichever is later. Refunds are determined by first, deducting non-refundable \$250 deposit, material costs, and fees, then a proration of the remainder amount is disbursed via check within 45 days. The \$50.00 electronic record keeping fee is non refundable to students who have completed the first week of class. No refund after 60% of attendance is completed.
