Definitions

This Program is new. Therefore, the number of student who graduated, the number of students who are placed, or the starting salary you can earn after finishing the educational program are unknown at this time. "STUDENT'S RIGHT TO CANCEL" - INSTITUTIONAL REFUND/DROP POLICY

• Any monies due the student shall be refunded within 30 days of official cancellation or withdrawal Pogeta And Alation or

Step 3: Non-refundable charges equal \$3,546 (equipment, supplies, and application fee),

Step 4: Amount paid is \$8,000.

Step 5: Refund Amount is \$1,327.44 (amount paid less earned instructional charges less non-refundable charges)

'STUDENT'S RIGHT TO CANCEL" - INSTITUTIONAL REFUND/DROP POLICY

- Any monies due the student shall be refunded within 30 days of official cancellation or withdrawal. Official cancellation or withdrawal shall occur on the earlier of the dates that:
 - a. A student is not accepted by the school. This student shall be entitled to a refund of all monies paid to the school except a non-refundable application fee.
 - b. Step 1: Hourly instructional charge is \$12.50625 (\$20,010/\$1600).

Step 2: Earned instructional charge is \$3,126.56 (\$12.50625 x 250).

Step 3: Non-refundable charges equal \$3,546 (equipment, supplies, and application fee),

Step 4: Amount paid is \$8,000.

Step 5: Refund Amount is \$1,327.44 (amount paid less earned instructional charges less non-refundable charges)
