STUDENT'S RIGHT TO CANCEL

STUDENT'S RIGHT TO CANCEL: The student has the right to cancel the Enrollment Agreement and obtain a refund of charges (minus the registration fee), paid through attendance at the first class session (first day of classes), or the 7th day after enrollment (seven calendar days from date when enrollment agreement was signed), whichever is later.
