STUDENT'S RIGHT TO CANCEL
(CA Private Postsecondary Education Act of 2009)

California Aeronautical University (CAU) is required to comply with the cancellation policy requirements outlined in the California Private Postsecondary Education Act of 2009). For students attending CAU locations (other than Santa Maria) and request to cancel their enrollment, the University will apply the requirements of the California Private Postsecondary Education Act of 2009. - A. Students have the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session or the seventh calendar day after enrollment, whichever is later. Definitions

- “Number of Students Who Began the Program” means the number of students who began a program who were scheduled to complete the program within 100% of the published program length within the reporting calendar year and excludes all students who cancelled during the cancellation period.
- “Students Available for Graduation” is the number of students who began the program minus the number of students who have died, been incarcerated, or been called to active military duty.
- “Number of On-time Graduates” is the number of students who completed the program within 100% of the published program length within the reporting calendar year.
- “On-time Completion Rate” is the number of on-time graduates divided by the number of students available for graduation.
- “150% Graduates” is the number of students who completed the program within 150% of the program length (includes on-time graduates).

STUDENT'S RIGHT TO CANCEL
(CA Private Postsecondary Education Act of 2009)

California Aeronautical University (CAU) is required to comply with the cancellation policy requirements outlined in the California Private Postsecondary Education Act of 2009). For students attending CAU locations (other than Santa Maria) and request to cancel their enrollment, the University will apply the requirements of the California Private Postsecondary Education Act of 2009. Refer to the Catalog Addendum for the current application fee cost.

- A. Students have the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session or the seventh calendar day after enrollment, whichever is later. After the end of the cancellation period, students also have the right to stop school at any time; they have the right to receive a pro rata refund if they have completed 60 percent or less of the period of attendance.
- B. Cancellation may occur when students provide a written notice of cancellation by mail or by hand delivery at the students' place of training:

- C. The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with proper postage.
- D. The written notice of cancellation need not take any particular form and, however expressed, it is effective if it shows that the student no longer wishes to be bound by the Enrollment Agreement.
- E. If the Enrollment Agreement is cancelled, the school will refund the student any money he/she paid, less a registration or administration fee not to exceed \$250.00. If a student is issued books or equipment and cancels their agreement for a program of instruction, the student is required to return the books or equipment within 30 days of the enrollment agreement being cancelled. A student who does not return the books or equipment, will be assessed a Computer and Sales Tax Fee. The total will not exceed \$800.00.
