STUDENT'S RIGHT TO CANCEL

Right to cancel date:

-The Notice of Cancellation shall be in writing and submitted directly to the Director or directors Ivan Contreras/Eddie Bello at 200 Atlantic Ave. Pittsburg ca, 94565, if sent by mail, it is effective when deposited and properly addressed with postage prepaid. A withdrawal may be initiated by the student's written notice or by institution due to the student's academics or conduct, including but not necessarily limited to, a student's lack of attendance. After the end of the cancellation period, you also have the right to stop school at any time and you have the right to receive a refund for part of the course not taken.
